Except in cases of deferral, confinement begins the date the sentence is adjudged. A legal "deferment" is one that is requested by the offender and approved by the Convening Authority ONLY. <u>NOTE</u>: New confinements and permanent releases do <u>NOT</u> require certified brig chasers for escort purposes.

<u>DISCLAIMER</u>: Failure to provide <u>all</u> required items below at time of confinement may delay the confinement process.

□ Original Confinement Order (<u>DD FORM 2707</u>) Latest Revision

1. Only the current version of the DD 2707 will be accepted.

- 2. The original confinement order must be <u>completely</u> filled out. NO copies accepted. Confining offenses <u>must</u> be listed on the confinement order.
- "Medical Certificate" section (9a-10d) <u>must</u> be signed and stamped by a Medical Officer, Nurse Practitioners (NP), or Physician Assistant (PA), certifying fitness for confinement. Any prisoner under the influence of drugs or alcohol (including withdrawal symptoms) and is <u>NOT</u> certified as fit for confinement will be turned away.
- 4. If a female is being confined, a pregnancy test <u>is</u> required and the results must be indicated on the confinement order.

□ **Results of Trial (ROT)**. Required for all confinement as a result of Courts-Martial.

□ **Pre-Trial Agreement (PTA)** – if applicable.

Charge Sheet (DD FORM 458) Pre-Trial Agreement (PTA). Signed by the accused, the defense counsel, trial counsel and the convening authority.

Victim/Witness Certification and Election Concerning Inmate Status (DD FORM 2704) Latest Revision

- 1. Only the current version of the DD 2704 will be accepted.
- 2. A DD 2704 is required for every sentence to confinement as a result of Courts-Martial even if there are no victims or witnesses.
- 3. DD FORM 2704 must be **<u>completely</u>** filled out by the Trial Counsel.

Prisoner Medical Record – if no record is available, provide <u>SF 600</u> with confinement physical documentation.

- **Prisoner Dental Record**
- Assignment Orders (PCS Orders) U.S. Army prisoners <u>ONLY</u>.
- □ Prisoner's military I.D. card (CAC card)
- □ Prisoner Medication Requirements If a post-trial prisoner is currently taking medication that medication <u>must</u> be brought with the prisoner to the brig at the time of local confinement. The medication <u>will</u> remain in the custody of the escort until turned over to brig staff.
- □ Prisoner Uniform / Health and Comfort (H&C) Items Requirements
 - > Refer to Uniform Requirements section on webpage.
 - > Only those (H&C) items that have <u>not</u> been previously opened will be accepted.
