## **Chief Petty Officer Uniform Requirements and Allowances**

Attention Chiefs and future Chiefs! Did you know that the special initial clothing allowance (SICA) only pays for items that are mandatory requirements for newly advanced Chiefs? Table 1 lists all required mandatory uniforms each Chief is expected to have in their sea bag immediately upon pinning. Having the required CPO uniforms is relative to knowing what needs to be in your sea bag, understanding your allowances, and knowing what is mandatory versus what is optional.

Your first allowance, SICA, is paid to active, TAR and selected reserve Chiefs upon the date of advancement vice date of frocking (Ref: DoD Financial Management Regulation Vol. 7A, Chapter 29). The SICA covers the cost of the items and respective quantities listed in Table 1. For FY 2023, the SICA rate is \$1,243.92 for male CPOs and \$1,214.88 for female CPOs. SICA is updated every year on 1 October to align with the new fiscal year's clothing requirements and updated costs.

All CPOs are expected to maintain various uniforms items also worn by junior enlisted personnel E1 - E6. Table 2 lists those E6 items required of a CPO that are supported by an annual clothing allowance (see description provided below). Item quantities to be maintained are relative to mission needs, but there is no mandatory minimum required.

Prices listed are effective 1 October 2022 through 30 September 2023. Uniform prices are set every Oct 1st. When absolutely necessary, prices may be adjusted during the FY.

Standard Cash Clothing Replacement Allowance(Standard CCRA): Paid annually during the first 3 years following receipt of SICA and at the end ofthe advancement anniversary month. The Standard CCRA supports the replacement of E6 clothing items based on their individual wear life.

Special Cash Clothing Replacement Allowance(Special CCRA):

Paid annually to CPOs after completion of 3 years time-in-rate at the end of the advancement anniversary month. The Special CCRA supports the replacement of CPO uniforms and E6 uniform items required of a CPO based on their individual wear life.

Reserve Chief Petty Officers will receive 18 percent of the Active Duty CPO Special Cash Clothing ReplacementAllowance. This allowance is paid annually during the anniversary month of the qualifying member.



Your Attention Please! Due to a supply chain issue, the standard choker collar devices will not be available for purchase and wear by CPOs who have yet to buy them. A tested and authorized suitable alternative is the standard CPO collar devices with a "smaller" yet much "stronger" backing clasp also referred to as clutch back. To facilitate standard CPO collar devices wear on the choker collar, center the standard collar device 1 ½ inch from the edge of the collar to the center of the anchor and fasten clear of the Velcro patch. Ensure the backings are firmly in place before donning the choker. Adjust each collar devices to ensure equal spacing from the edge of the collar. Use of the smaller size backing clasps is intended to prevent rubbing against the neck that might be incurred with the standard size insignia clasp. This policy will be in place until we have obtained another source and sufficient inventory of the traditional CPO choker rank devices.





## **Things to Remember!**

Bottom line up front, know what you need and get it early! The closer/better the off-the-rack uniform fit, the less alterations required and the less money you'll have to spend. If you can't find your size, ask the uniform store attendant. Waiting until the last minute to procure your uniforms may result in your desired size component not being available when needed and you having to settle for the next best fit, which could require expensive alterations. Knowing the difference between mandatory (CPO sea bag requirements) and optional items (nice to have) can save you allowance dollars. Your allowances cover mandatory items only.

**Male khaki shirts**: Worn by E1 through O10 are the same fabric, design and quality specifications! The difference in price of the two shirts is due to different distributors/manufacturers.

CNT khakis are authorized for wear: Shirts, slacks and skirts worn must be of the same fabric.

Female Officer/CPO Summer White Slacks and Skirts are authorized for wear with the Service Dress White Coat.

**New CPOs:** Choose a payment or payment plan that aligns with your ability to procure your required uniforms prior to wearing the HAT. O% interest option for 12 months is recommended for those who desire to defer full payment until receipt of SICA. Coincidently, the deferred payment limit is \$1250, which aligns with your SICA payment. For those who are able to purchase their uniform requirements up front and fully out-of-pocket, there are money savings options for you to consider as well.

**Navy Blue Coveralls:** The navy blue coveralls have transitioned to organizational clothing and are now available in the supply system via the Defense Logistics Agency (DLA) NSN 8405-01-057-3482.
