1. THE AVIATION WARFARE TRANSITION BOARD IS SCHEDULED FOR 13 JUNE 2024.

2. BACKGROUND: THE PURPOSE OF THE AVIATION WARFARE TRANSITION BOARD IS TO PROVIDE 131X OR 132X OFFICERS THE OPPORTUNITY TO TRANSITION TO DIFFERENT PLATFORM WITHIN THEIR DESIGNATOR. EACH APPLICANT WILL BE INDIVIDUALLY EVALUATED BASED ON FITREP PERFORMANCE, CAREER TIMING, AND THE NEEDS OF THE RESPECTIVE GAINING AND LOSING COMMUNITIES. TRANSITION BOARDS ARE CONDUCTED EVERY JUNE AND DECEMBER IN ACCORDANCE WITH MILPERSMAN 1542-020.

3. REQUIREMENTS FOR CONSIDERATION ARE LISTED IN REFERENCE A.

4. APPLICATIONS:

A. THE VRM COMMUNITY IS STILL ACCEPTING APPLICATIONS FOR THE WARFARE TRANSITION BOARD. OFFICERS FROM THE HSC, HM AND VRC COMMUNITIES WILL STILL CONTINUE TO BE DIRECT DETAILED TO THE VRM COMMUNITY AS APPLICABLE AND AVAILABLE. OFFICERS INTERESTED IN A VRM TRANSITION FROM ALL OTHER COMMUNITIES ARE ENCOURAGED TO APPLY TO THE WARFARE TRANSITION BOARD.

B. FORMAT: APPLICATION FORMAT IS LISTED IN REFERENCE A.

C. MEDICAL SCREENING: A COPY OF YOUR CURRENT FLIGHT PHYSICAL OR LETTER FROM THE FLIGHT SURGEON STATING THE MEDICAL SERVICE GROUP (1, 2, 3) IS REQUIRED.

D. ENDORSEMENTS: ALL ENDORSEMENTS SHOULD SPECIFICALLY ADDRESS PERFORMANCE IN RELATION TO PEERS AS WELL AS TACTICAL ACUMEN, AIRMANSHIP, HEADWORK, SITUATIONAL AWARENESS AND AN OVERALL ASSESSMENT OF THE APPLICANTS EXPECTED PERFORMANCE AS A PILOT/NFO. REPORTING SENIORS ARE STRONGLY ENCOURAGED TO COMPETITIVELY RANK ALL APPLICANTS IN THEIR ENDORSING CHAIN.

E. ORDERS: THE CO LETTER OF ENDORSEMENT SHALL BE WRITTEN WITH THE UNDERSTANDING THAT IF THE INDIVIDUAL IS ACCEPTED, THE INDIVIDUAL MAY DETACH WITHIN 2 MONTHS UPON RELEASE OF THE RESULTS OR COMPLETION OF CURRENT DEPLOYMENT.

5. OBLIGATED SERVICE REQUIREMENTS FOR ACCEPTED APPLICANTS (IAW REF A):

A. AN OFFICER WHO IS ACCEPTED FOR TRANSITION FROM ONE WARFARE SPECIALTY TO ANOTHER SHALL INCUR 60 MONTHS OBLIGATED SERVICE UPON COMPLETION OF TRAINING.

B. ANY OFFICER FAILING TO COMPLETE TRAINING SHALL BE RETURNED TO ORIGINAL COMMUNITY AND INCUR 24 MONTHS OBLIGATED SERVICE UPON DETACHMENT OF TRAINING DUTY STATION.
