1. THE NFO TO PILOT PROGRAM SELECTION BOARD IS SCHEDULED FOR 22 JUNE 2022.

2. BACKGROUND: THE NFO TO PILOT PROGRAM SERVES AS A RECRUITING AND RETENTION PROGRAM FOR NAVAL AVIATION. THE PROGRAM IS OPEN TO NFOS FROM ALL COMMUNITIES. TO ENSURE CAREER PROGRESSION FOR THOSE SELECTED, ELIGIBILITY IS RESTRICTED TO NFOS WHO ARE YG 17 AND JUNIOR. ALL APPLICANTS MUST MEET THE REQUIREMENTS IN REFS A AND B. TO FACILITATE CAREER TIMING/PROGRESSION, UNIT COMMANDERS SHOULD EXPECT SELECTS TO DEPART IMMEDIATELY FOR PRIMARY FLIGHT TRAINING. NFO TO PILOT BOARDS ARE CONDUCTED EVERY JUNE AND DECEMBER.

ENDORSEMENTS: ALL ENDORSEMENTS SHOULD SPECIFICALLY ADDRESS PERFORMANCE IN RELATION TO PEERS AS WELL AS TACTICAL ACUMEN, AIRMANSHIP, HEADWORK, SITUATIONAL AWARENESS AND AN OVERALL ASSESSMENT OF THE APPLICANTS EXPECTED PERFORMANCE AS A PILOT. REPORTING SENIORS ARE STRONGLY ENCOURAGED TO COMPETITIVELY RANK ALL APPLICANTS IN THEIR ENDORSING CHAIN. A UNIT COMMANDER'S ENDORSEMENT SHALL BE WRITTEN WITH THE UNDERSTANDING THAT IF SELECTED, THE APPLICANT IS

AVAILABLE TO DETACH FOR REDESIGNATION TO PILOT BASED ON CAREER MILESTONE TIMING.

E. ORDERS: UNIT COMMANDERS SHOULD EXPECT SELECTS TO DETACH FOR PRIMARY FLIGHT TRAINING IMMEDIATELY UPON SELECTION. ACTUAL DETACH TIMING

WILL BE DETERMINED BY PERS-43 PERSONNEL WITH THE PRIMARY FACTOR BEING CAREER TIMING/PROGRESSION.

F. REF A STATES THAT APPLICANTS FOR TRAINING AS A NAVAL AVIATOR MUST NOT HAVE PASSED THEIR 32ND BIRTHDAY AT THE TIME THE BOARD CONVENES, 22 JUNE 2022. AGE WAIVERS FOR THIS REQUIREMENT MAY BE GRANTED BY THE AVIATION OFFICER COMMUNITY MANAGER ON A CASE-BY-CASE BASIS.

5. OBLIGATED SERVICE REQUIREMENTS FOR ACCEPTED APPLICANTS (IAW REF A):

A. ACCEPTED APPLICANTS SHALL NOT RESIGN FROM NAVAL SERVICER DURING THE COURSE OF STUDENT PILOT INSTRUCTION. UPON DESIGNATION AS A 1310, ACCEPTED APPLICANT AGREES TO SERVE ON ACTIVE DUTY FOR A PERIOD OF EIGHT YEARS OR UNTIL COMPLETION OF PREVIOUSLY INCURRED OBLIGATED SERVICE, WHICHEVER IS LONGER, UNLESS RELEASED EARLIER BY THE NAVY.

B. ACCEPTED APPLICANTS FAILING TO COMPLETE THE NAVAL AVIATOR

TRAINING PIPELINE (PRIOR TO BEING DESIGNATED A 1310) FOR REASONS OTHER THAN PHYSICAL, SHALL RETURN TO ORIGINAL COMMUNITY AS A NAVAL FLIGHT OFFICER (1320) AND WILL SERVE FOR THREE YEARS FROM THE DATE OF DISENROLLMENT FROM PILOT TRAINING, OR UNTIL COMPLETION OF A PREVIOUSLY INCURRED OBLIGATION, WHICHEVER IS LONGER, UNLESS RELEASED EARLIER BY THE NAVY.

C. ACCEPTED APPLICANTS DISENROLLED BECAUSE OF PHYSICAL DISQUALIFICATION WILL SERVE ON ACTIVE DUTY UNTIL COMPLETION OF PREVIOUSLY INCURRED MINIMUM REQUIRED SERVICE UNLESS RELEASED EARLIER BY THE NAVY.
