All Command Qualification Board recommendation letters must be submitted IAW COMNAVIFORINST 1412.2 to the NAVIFOR POC, Mr. Joseph C. Sullivan, joseph.c.sullivan@navy.mil. Packages will be processed by NAVIFOR. If the NAVIFOR endorsement letter is not in your record (AQD 2D1), include it in your correspondence to the board (must be received by 2359 CST 5 September 2019.) Recommendation letters signed by Commanding Officers or board members do not constitute Command Qualification.

Only eligible officers may communicate with a selection board. Written communication may invite to the attention of the board any matter concerning himself/herself that the officer considers important. The written communication must be in accordance with MILPERSMAN 1420-010 and may include, as enclosures, correspondence from any individual concerning the eligible officer. Correspondence not originated by the eligible officer, including endorsements to the officers letter and letters written on behalf of that officer, must contain a written acknowledgement by the eligible officer that he or she desires that such correspondence be presented to the board. Correspondence without such acknowledgment is considered third party correspondence and will be returned. Classified correspondence will not be accepted.

Correspondence must arrive in the board spaces not later than 2359 CST 5 September 2019 and shall be addressed to: Navy Personnel Command (NPC) MyNavy Career Center (MNCC), President, FY-20 O-5/O-6 Information Warfare Community Command and Milestone Screen Board #425, 5720 Integrity Drive, Millington, TN 38055-6300. Navy Personnel Command members (detailers, etc.) are specifically prohibited from delivering correspondence to the board.

Any eligible Officer who prefers not to be considered for a Milestone, Command, or IWC assignment should submit a written statement to the President of the Board requesting to be removed from consideration and board eligibility. A sample "Don't Pick Me" letter is provided under Board Preparations in link above. A "Don't Pick Me" letter must be provided each year of board eligibility. Officers desiring to be removed from consideration may include in their statements their reasons for doing so, if desired.

Eligible Officers are encouraged to thoroughly review their OSR/PSR and FITREP continuity prior to the convening of the board to identify and address discrepancies. Contact your detailer for more information.
