

FY-22 INFORMATION WARFARE COMMUNITY O4 MILESTONE AND LEADERSHIP SCREENING BOARD ANNOUNCEMENT

THE FY-22 INFORMATION WARFARE COMMUNITY O4 MILESTONE AND LEADERSHIP SCREENING BOARD (#426) WILL CONVENE ON 16 NOVEMBER 2020.

INFORMATION WARFARE COMMUNITY OFFICERS WILL HAVE TWO OPPORTUNITIES TO BE SCREENED FOR LIEUTENANT COMMANDER MILESTONE AND LIEUTENANT COMMANDER LEADERSHIP. THE FOLLOWING INFORMATION WARFARE OFFICERS WILL BE ELIGIBLE FOR THE FY-22 INFORMATION WARFARE COMMUNITY O4 MILESTONE AND LEADERSHIP SCREENING BOARD (#426)

OCEANOGRAPHY (1800)

- LIEUTENANT COMMANDER MILESTONE: THE FIRST LOOK WILL OCCUR WHEN OFFICERS HAVE REACHED 6 YEARS OF COMMISSIONED SERVICE AND HAVE SERVED IN AN OCEANOGRAPHY BILLET FOR AT LEAST 12 MONTHS AS OF THE LAST DAY OF THE MONTH PRIOR TO THE CONVENING OF THE SCREENING BOARD. SECOND LOOK OPPORTUNITY WILL OCCUR THE FOLLOWING YEAR FOR THOSE OFFICERS NOT SELECTED FOR LCDR MILESTONE DURING THE FIRST LOOK OPPORTUNITY.
- LIEUTENANT COMMANDER LEADERSHIP: PROMOTION YEAR GROUPS (PYG) 18 AND 19.

CRYPTOLOGIC WARFARE (1810)

- LIEUTENANT COMMANDER MILESTONE: PYG 20 AND 21
- LIEUTENANT COMMANDER LEADERSHIP: OFFICERS IN PYG 18 AND SENIOR WHO HAVE ALREADY HAD ONE LOOK OPPORTUNITY, WILL HAVE A SECOND LOOK OPPORTUNITY REGARDLESS OF MILESTONE STATUS. AN OFFICER'S FIRST LOOK OPPORTUNITY WILL OCCUR IF AN OFFICER IS IN OR COMPLETE WITH LIEUTENANT COMMANDER MILESTONE PRIOR TO THE CONVENING OF THIS BOARD.

INFORMATION PROFESSIONAL (1820)

- LIEUTENANT COMMANDER MILESTONE: PYG 20 AND 21
- LIEUTENANT COMMANDER LEADERSHIP: OFFICERS IN PYG 18 AND SENIOR WHO HAVE ALREADY HAD ONE LOOK OPPORTUNITY WILL HAVE A SECOND LOOK OPPORTUNITY REGARDLESS OF MILESTONE STATUS. AN OFFICER'S FIRST LOOK OPPORTUNITY WILL OCCUR IF AN OFFICER IS IN OR COMPLETE WITH LIEUTENANT COMMANDER MILESTONE PRIOR TO THE CONVENING OF THIS BOARD.

INTELLIGENCE (1830)

- LIEUTENANT COMMANDER MILESTONE: PYG 20 AND 21
- LIEUTENANT COMMAND LEADERSHIP: OFFICERS IN PYG 18 WHO HAVE ALREADY HAVE ALREADY HAD ONE LOOK OPPORTUNITY WILL HAVE A SECOND LOOK REGARDLESS OF MILESTONE STATUS. OFFICERS IN PYG 19 WHO HAVE EITHER BEEN SUCCESSFULLY SCREENED FOR LIEUTENANT COMMANDER MILESTONE OR HAVE COMPLETED LIEUTENANT COMMANDER MILESTONE WILL RECEIVE A FIRST LOOK OPPORTUNITY

LATE ACCESSIONS AND LATERAL TRANSFERS SENIOR TO PYG 2020 NOT PREVIOUSLY SCREENED FOR LIEUTENANT COMMANDER MILESTONE WILL BE CONSIDERED SCREENED AND ELIGIBLE FOR MILESTONE ASSIGNMENT. THESE OFFICERS WILL BE GIVEN THE OPTION TO DEFER THEIR INITIAL ELIGIBILITY FOR THE LEADERSHIP SCREENING FOR UP TO ONE YEAR.

NOTIFICATION TO ALL LAST LOOK NON-SELECTS WILL BE MADE BY RESPECTIVE COMMUNITY DETAILERS ONCE THE BOARD IS ADJOURNED.

ONLY ELIGIBLE OFFICERS MAY COMMUNICATE WITH AN ADMINISTRATIVE BOARD. WRITTEN COMMUNICATION MUST BE SIGNED BY THE BOARD ELIGIBLE OFFICER, IN ACCORDANCE WITH MILPERSMAN 1420-010, AND MAY INCLUDE, AS ENCLOSURES, CORRESPONDENCE FROM ANY INDIVIDUAL CONCERNING THE ELIGIBLE OFFICER. CORRESPONDENCE NOT ORIGINATED BY THE ELIGIBLE OFFICER, INCLUDING ENDORSEMENTS TO THE OFFICERS LETTER, AND LETTERS WRITTEN ON BEHALF OF THAT OFFICER MUST CONTAIN A WRITTEN ACKNOWLEDGEMENT BY THE ELIGIBLE OFFICER THAT HE OR SHE DESIRES THAT SUCH CORRESPONDENCE BE PRESENTED TO THE BOARD. CORRESPONDENCE WITHOUT SUCH ACKNOWLEDGEMENT IS CONSIDERED THIRD PARTY CORRESPONDENCE AND WILL BE RETURNED. CLASSIFIED CORRESPONDENCE WILL NOT BE ACCEPTED.

NAVY PERSONNEL COMMAND MEMBERS (DETAILERS, ETC.) ARE SPECIFICALLY PROHIBITED FROM DELIVERING CORRESPONDENCE TO THE BOARD. CORRESPONDENCE MUST ARRIVE IN THE BOARD SPACES NOT LATER THAN **2359 CENTRAL STANDARD TIME (CST) 12 NOVEMBER 2020**.
