SUBJECT: Approval of June 2023 Experience-Based Joint Duty Assignment Review Board Recommendations

- 1. On 6 June 2023, the Joint Staff convened an O-6 Experience-Based Joint Duty Assignment (E-JDA) review board. The board was held in accordance with Chairman of the Joint Chiefs of Staff Instruction (CJCSI) 1330.05B, 6 Jul 2020, "Joint Officer Management Program Procedures." The board considered 32 O-6 joint experience nominations, submitted by officers via their respective Services, for joint credit. The recommendations of the board (Attachment A) are hereby approved as follows: 28 are approved to receive joint experience points and 4 submissions are disapproved.
- 2. On 7-8 June 2023, the Joint Staff convened an O-5 and Below Experience-Based Joint Duty Assignment (E-JDA) review board. The board considered 265 joint experience nominations, submitted by officers via their respective Services, for joint credit. The recommendations of the board (Attachment B) are hereby approved as follows: 99 are approved to receive joint experience points and 166 submissions are disapproved.
