SUBJECT: Approval of May 2026 Experience-Based Joint Duty Assignment Review Board
Recommendations

1. On 18 May 2026, the Joint Staff convened an O-6 Experience-Based Joint Duty Assignment (E-JDA) review board. The board was held in accordance with Chairman of the Joint Chiefs of Staff Instruction (CJCSI) 1330.05B, "Joint Officer Management Program Procedures." The board considered 34 O-6 joint experience nominations, submitted by officers via their respective Services, for joint credit.
