1. Date and Location

- a. This administrative selection board, consisting of you as president, the members listed in enclosure (1) as board members, and the personnel listed in enclosure (2) as administrative support staff are ordered to convene at Navy Personnel Command, Millington, TN at 0800, 17 June 2024, or as soon as practicable thereafter.
- b. The board shall proceed in accordance with all guidance in this letter and the FY-25 Administrative Selection Board Precept, reference (a).
- 2. Function. The function of the board is to recommend:
- a. Eligible officers in the Supply Corps (Captain (3100) for assignment to Supply Corps Major Command Ashore billets;
- b. Review the performance of previously selected officers in the Supply Corps Major Command Ashore bank, and recommend for removal, if warranted.

3. 3100 Board Authorized Selections

a. The total number of candidates that may be recommended for Supply Corps (3100) Major Command Ashore is <u>ten</u>. The FY-25 screen goals are based on actual command billet requirements in Calendar Year (CY) 2025. All Supply Corps Captains (3100) that meet the requirements of reference (b) are eligible for consideration by the board.

Subj: ORDER CONVENING THE FY-25 SUPPLY CORPS CAPTAIN MAJOR COMMAND ASHORE SCREEN BOARD

b. Special Requirements:

- (1) Select to the skill sets in paragraph 3.b.(2) below to the maximum extent possible. If the skill set selection goal cannot be met, you should still attempt to select to the total overall selection goal as outlined in paragraph 3.a. above.
- (2) Members of the Defense Acquisition Corps are uniquely qualified to fill Critical Acquisition billets. Members of the Defense Acquisition Corps, are identified by the "APM" Additional Qualification Designator (AQD).
- (3) Based on seven Critical Acquisition Contract Management billets, the inclusive selection goal is:
 - (a) Defense Acquisition Corps Member (APM AQD)
 - (b) Certified DAWIA CONTRACTING (ACA AQD)
 - (c) 1306Q or 1306R subspecialty

- 5. <u>Additional Guidance</u>. The below information is provided to clarify community requirements and any specific needs, but in no way should replace the Best and Fully Qualified Standard of reference (a).
- a. Only those officers who comply with reference (b), fulfilling command qualification requirements, will be eligible for consideration. The final actual eligible numbers will be determined as of the date the board convenes.
- b. Officers who submit written or emailed requests to not have their record considered for the screen will be ineligible and their record will not be screened.
- c. Officers with approved retirement or separation orders, and officers whose retirement or separation requests have been received by PERS-8, will be ineligible and their record will not be screened.
- d. The board shall document skill sets of those officers selected to determine attainability of selection goals as outlined in paragraphs 3.b.(2).
- 6. The board need not select to the numbers provided. The authorized number to select should only be attained if there are a sufficient number of candidates determined best and fully qualified.
