DIVO Shore Slate Policies:

Below summarizes the highlights of the shore slating process for CVN DIVOs. Please contact the SWO(N) Community Management Team if you have any questions.

- Detailing Waterfall
 - Talent Management Board (TMB) held every August. No obligation to apply. If selected for program, accept the billet by submitting a DHRB contract within seven days. Billet will pass to next officer if no DHRB contract submitted. No penalty or obligation incurred!
 - Nuclear Shore Slate Only If applying to only nuclear shore billets listed on page 18 of the SWO(N) Community Brief, linked in the website below, list only the billets to be considered for outside of the normal slating process detailed below. Not obligated for shore by submitting these preferences!
 - SWO(N) Required Billets Listed with the conventional slate but only available to SWO(N)s. Higher probability of being awarded one of these billets but would be obligated for shore duty and does not satisfy the nuclear shore requirement either post DIVO or CVN Principal Assistant.
 - Conventional Shore Slate Compete with all SWOs for shore billets and committing to shore duty. All bullets below apply to the Conventional Shore Slate only.
- DIVOs must provide their top 20 shore preferences to the Detailer. If only five preferences are provided, that indicates that all other billets are a tie for the sixth preference, so provide the full 20! Preferences and CO inputs are required before slating. Once you submit preferences for this slate, you've negotiated for orders and must execute those orders.
- Officers listing "DHRB required" billets in their top 10 choices do so with the understanding that they will be expected to submit a DHRB contract within 14 days of slate notification of assignment to that billet. Failure to submit a contract will subject that officer to a re-slate. An officer assigned to his/her #11 or higher preference will not be required to sign DHRB for billets listed as "DHRB REQ."
- WTIs, including Officers who have selected WTI (KWS) or have been Red Chipped by the Commanding Officer, must include at least 3 WTI coded billets in their preferences. If an officer is WTI coded or WTI Select (KWS) this does not guarantee to be slated to a WTI coded tour; it is a consideration in selecting your billet to fill.
 - WTI is a viable option for SWO(N)s; there are currently 14 active SWO(N) WTIs!
- Since the nuclear and conventional shore slates are combined, all SWO(N)s must submit at least one nuclear billet in their preferences on page 18 of the community brief (regardless of whether or not they have taken/passed their Nuclear Engineer Officer's exam) in addition to listing Shift Engineer at Prototype in your top 20 preferences.
- With the change in allowing conventional SWOs to fill their second DIVO tours in DESRON/PHIBRON/MCMRON billets, officers are no longer required to include those billets in their top 20 preferences. If interested in these billets please contact the detailer

to discuss available options to include in your preferences. If they are included in the preferences, the officer will be considered a volunteer for those billets.

• Committing to shore duty does not obligate DIVOs for Department Head. It does give DIVOs a chance to recharge and make major life decisions outside of a the significant demands of sea duty while getting paid more!
