# Cryptologic Technician (Collection) (CTR) Conversion Package

-Updated April 2024-

### \*\*\* Please read this document in its entirety to understand the process on conversion to CTR \*\*\*

Conversion to CTR is done outside of My Navy Assignments/CWAY. It is imperative that the Sailor and their COC communicate with the CTR ECM throughout the process. Any questions, contact the CTR ECM.

#### SSO/CSMs PLEASE BE ADVISED: Commands <u>do not</u> conduct the T5 investigations for Sailors undergoing PACT/Lateral/Force conversion into an Information Warfare Community Rating. If tentatively approved, the Fleet Cyber Command / USCOMTENTHFLT SSO will initiate.

- Step 1) Talk to your Command Career Counselor to see if you are ASVAB eligible. If you are not, check the current CTR Community Overview on the CTR Community Page for guidance on ASVAB Point Waivers
- Step 2) Understand the OBLISERV requirements
- Step 3) Call the CTR TechAd at 901-874-2286 for questions and pre-screening
- Step 4) Submit the Package requirements to MNCC
- Step 5) Submit the SF 86 to the CTR TechAd either via ENCRYPTED email or DoD Safe (*if you use DoD Safe, please do not forget to send the passphrase via a separate email*)
- Step 6) Call the CTR TechAd at 901-874-2286 for the way forward
- Step 7) Be Patient. Getting the clearance takes time, we'll discuss this when you call.

Step 8) Once the interim SCI is granted, the CTR TechAd will contact you to schedule A school

<u>NOTE</u>: Based on the results of the initial screening interview, the TechAd will advise the Sailor to submit the conversion package.

<u>NOTE</u>: Please do not contact the CTR detailers. The CTR TechAd will be your main point of contact through the conversion process and will put you in contact with the CTR detailers when appropriate.

**NOTE:** CTR A School is over 20 weeks/140 days and as such, IAW MPM 1320-300, garners an accounting category code (ACC) of 342, "PCS Status for Training Courses of 20 Weeks or More. Member is ordered to attend a course(s) of instruction at a school or installation where the scheduled cumulative duration is more than 140 days (20 weeks). The school or installation is the member's PDS, regardless of the terms of the orders involved. (Reference (a), paragraph 2240-B)," meaning Sailors will PCS to Pensacola and that **those eligible** will receive BAH for Pensacola while attending CTR A School. Please be prepared to plan accordingly.

\_\_\_\_\_: I, \_\_\_\_\_, am volunteering for the Aircrew Program. I understand the following concerning rigorous physical requirements of the Aircrew Program:

1. I am volunteering for aircrewman duty, which necessarily includes naval aircrewman candidate school. If I voluntarily disenroll from training as an aircrewman student, I will no longer be eligible for further aircrew training. Initial: \_\_\_\_\_

2. I can swim. Initial: \_\_\_\_\_

3. I must pass the Navy physical fitness assessment (PFA) with a "satisfactory" in all categories to enter aircrew school. Initial: \_\_\_\_\_

4. I must meet the following minimum physical fitness requirements **to graduate** from aircrew school: a. Be able to perform extensive daily calisthenics.

b. Pass a Navy PFA with a "good" in all categories for my age and gender.

c. Swim:

(1) 1 mile in flight suit in 80 minutes or less using sidestroke, breaststroke, or American crawl.

(2) 100 yards in full flight gear (flight suit, boots, helmet, gloves, and deflated life preserver) using each of the survival strokes for 25 yards (sidestroke, breaststroke, elementary backstroke, and American crawl), followed immediately by a 5-minute drown-proofing (face-down prone float).

(3) In full flight gear, tread water for 2 minutes followed immediately by 3 minutes of drownproofing.

(4) 200 yards (50 yards each using breaststroke, elementary backstroke, sidestroke, and American crawl).

(5) Jump from a 12-foot tower and then swim 15 yards underwater wearing flight suit and boots using a modified breaststroke, immediately followed by floating using trouser inflation techniques.

(6) 75-yard flight equipment swim using breaststroke only.

(7) 100-yard swim using 25 yards sidestroke, 25 yards breaststroke, 25 yards elementary backstroke, and 25 yards American crawl. Initial: \_\_\_\_\_
