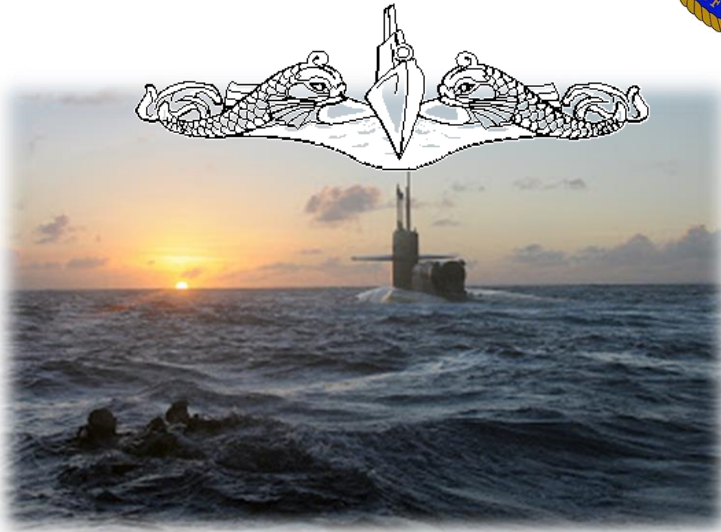


Enlisted Supervisor Retention Pay (ESRP)

Program Description

- The ESRP program is a flexible incentive program tailored to meet the retention goals of specific skill sets. ESRP reenlistment time in service eligibility zones are defined as follows:
 - Zone 1: Greater than or equal to 10 years of naval service but less than 14 years of naval service.
 - Zone 2: Greater than or equal to 14 years of naval service but less than 17 years of naval service.
 - Zone 3: Greater than or equal to 17 years of naval service but less than 23 years of naval service.



Eligibility Criteria

- Have completed at least 10 years but fewer than 23 years of naval service at the time the new reenlistment contract becomes effective.
- Meet all eligibility requirements per NAVPERS 15560D to reenlist for a minimum of three years in the Navy. The term of reenlistment must be in whole year increments, and limited to a maximum of six years. ESRP is not authorized for enlistment contract extensions.
- Be on Active Duty.
- Be a Petty Officer of paygrade E-5 or above.
- Hold an ESRP-designated rating or skill (per current ESRP NAVADMIN).



Eligibility Criteria

- The terminal date for the new reenlistment contract **must be at least 24 months past the existing enlistment contract obligation** (end of active obligated service (EAOS) or EAOS as extended (Soft EAOS), whichever is later).
- Receive approval from the ESRP Program Manager prior to executing an ESRP reenlistment. Requests for new ESRP reenlistment contracts with terminal dates that would exceed the high year tenure (HYT) for the Service Member's current rank will not be approved unless a HYT waiver request is granted.
- The term of a Zone 1 reenlistment must obligate service through the end of Zone 1 and into Zone 2. The term of a Zone 2 reenlistment must obligate service through the end of Zone 2 and into Zone 3.



Authorization Procedures

- NSIPS is only method of submission. If the command is unable to submit ESRP reenlistment requests due to operational commitments, then the command's **ISIC** may submit the request via NSIPS.



ESRP Award Computation

- Obligated Service (OBLISERV) beyond completion of 23 years total active service may not be used to compute ESRP contract award amount.
- ESRP may not be paid for any service remaining on the current enlistment, excluding inoperative agreement(s) to extend enlistment.
- When computing the active OBLISERV remaining on the current enlistment for which ESRP cannot be paid, a fraction of a month will be rounded up to the next whole month.



ESRP Award Computation

- ESRP Zone 1 compensation will be calculated no further than through completion of 16 years of service.
- ESRP Zone 2 compensation will be calculated no further than through completion of 18 years of service.
- ESRP Zone 3 compensation will be calculated no further than through completion of 23 years of service.



ESRP Award Computation

- A Service Member cannot exceed combined SRB and ESRP payments totaling **\$360,000** in a career.
- This combined total only includes SRB and ESRP bonus payments from reenlistments dated 1 October 2013 and forward.
- Max \$30,000 per 12 months of AOS.
- The effective maximum ESRP bonus is \$150,000 per reenlistment contract which requires a minimum of 60 months of AOS by calculation.
- $ESRP = (\text{Base Pay} \times \text{Multiple} \times \text{AOS}(\text{months}) / 12$



Reenlistment Contract Length

- Zone 1 and zone 2 ESRP reenlistment contracts must extend into the next reenlistment zone.
- ESRP reenlistments must be a minimum of three years and maximum of six years.
- ESRP reenlistments must add a minimum of 24 months past SEAOS.
- ESRP compensation is limited to the completion of 23 years of active service.



Payment Structure

- The ESRP Zone 1 payment structure includes
 - a one-time lump sum payment or
 - an anniversary payment structure.
- Sailors must correctly identify their **preferred payment structure in NSIPS.**
- The ESRP Zones 2 and 3 payment structures are identical to the Selective Reenlistment Bonus program.



Payment Structure

- Payments will be released by the ESRP program manager through DFAS, after the reenlistment is posted electronically. Commands should contact the ESRP program manager, not DFAS, with questions regarding payments.
- Service Members will receive annual ESRP installments during the anniversary month of their reenlistment date.
- Prior to each anniversary installment, OPNAV N133 reviews each record for continued entitlement eligibility.

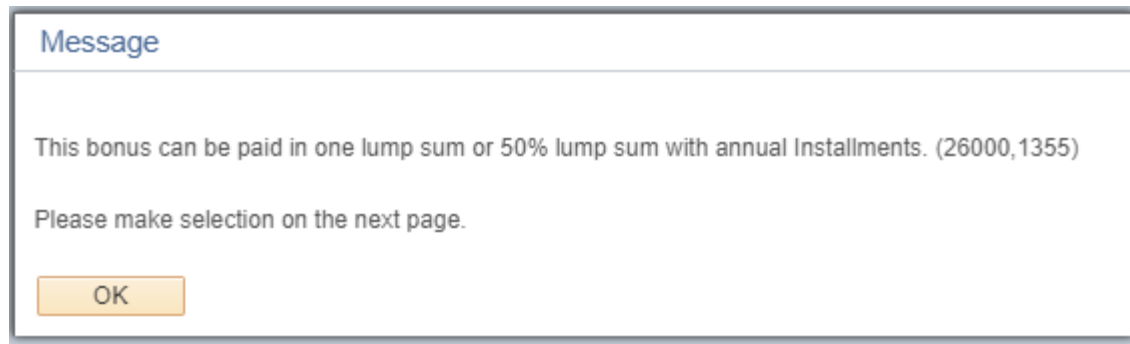

Changes??

- Once an ESRP request has been submitted, the ESRP program manager **MUST** be notified of any changes, including but not limited to:
 - Requesting to change the date of reenlistment
 - Requesting to change the term of reenlistment
 - Requesting to change the payment option for Zone 1
 - Requesting to change the paygrade of the reenlistee
 - Requesting to cancel the submitted request
 - ANY changes!
