Nuclear CCC Quick Reference Guide

- <u>Conditional Releases</u> NAVADMIN 177/17
 - a. Not required for LDO (N) or STA-21(N). Required for OCS (N) & any other non-nuclear commissioning programs.
 - b. Submit conditional release NAVPERS 1306/7 directly to the applicable nuclear detailer via email.
 - c. Approvals will receive conditional release letter. No correspondence for disapprovals.
 - d. Requests for Commissioning Programs to another service are adjudicated by PERS832 via detailer and N133.
- <u>Nuclear NECs</u> OPNAVINST 1220.1 (SERIES)
 - a. Navy Enlisted Classification (NEC) Change Request (NAVPERS 1221/6) must be signed by CO (RO on a CVN).
 - b. Corrections: (N91T to N1XO/N2XO) email to <u>bullnuke@navy.mil</u>. 1221/6 not required.
 - c. NEC Change Requests N1XS/N2XS/N33Z/N71Z/N72Z/N89X/N59X: 1221/6 email to bullnuke@navy.mil
 - i. Frequent submissions errors:
 - 1. No waivers for E4 and below.
 - 2. Waivers for 4 year TIS requires the Sailor to be EWS/PPWS qualified.
 - 3. Qualification dates are required to be on the 1221/6 per the chart in OPNAVINST 1220.1F.
 - 4. Using templates but not verifying all the information on the template.
 - ii. Sailor's Bonus payments and SDAP will be stopped upon submission of N89X/N59X NEC.
 - d. Nuclear NEC Removal (774B) Performance based removals on submarines require ISIC endorsement on blocks 20-24.
 - e. RDMC (N31Z) forward 1221/6 to N133 FORAC. EDMC (N32Z) Submit 1221/6 through ISIC to TYCOM for TYCOM endorsement on blocks 20-24. TYCOM forwards to N133 FORAC.
 - f. Sub To Surface -1221/6 submitted to <u>bullnuke@navy.mil</u> with medical documentation.
 - g. Surf to Sub -1306/7 submitted directly to detailer. They will forward to N133 FORAC.
 - h. NEC Restoration:
 - i. NEC Restoration (from N_9X) Requires 1221 and substantiating documentation pertinent to the case.
 - ii. NEC Reinstatement (from 774B). Requires endorsement by ISIC and TYCOM prior to submission to N133.
 - i. 8MTS Not processed through N133. These need to be sent to MILL_NEC_REQUEST@NAVY.MIL.
- <u>Reenlistments/Bonuses</u> OPNAVINST 1160.8 (SERIES), ESRP Policy Memorandum.
 - a. A Sailor's half upfront reenlistment bonus payment is paid upon reenlistment, however earning **this bonus money does not begin until they have passed the date of their previous EAOS at time of reenlistment** (i.e., additional obligated service (AOS). Sailors will pay back all monies paid to them for any unearned portion of their contract not served.
 - b. SRBs/ESRPs are submitted in NSIPS by CCC. Bonus cap is \$100K/contract NTE \$30K/12 months of AOS (\$2500/month) and a lifetime cap of \$360K. Nukes can reenlist at any point in the reenlistment zone. Max of 6 year reenlistment.
 - c. Reenlistments are in 12 month increments, SRB/ESRP reenlistment requires a minimum of a 3 year reenlistment.
 i. \$\$\$ = (Base Pay(on date of discharge) X Multiple X AOS) /12
 - d. AOS computation for ESRP Z1 stops at 16 YOS, ESRP Z2 at 18 YOS, and ESRP Z3 at 23 YOS, with a minimum of 24 months OBLISERV past current SEAOS.
 - e. Sailor can use SRB calculator on NSIPS ESR homepage to estimate their bonus. POC: mill_incen_pays@navy.mil
 - f. Zone Eligibility Criteria:
 - i. A member may receive only one SRB/ESRP per zone during a career.
 - ii. When reenlisting for SRB/ESRP, the reenlistment must take the new EAOS into the next SRB/ESRP zone.

 - c. EXTENSIONS MPM 1160-040 Extensions > 23 months require approval from OPNAV N-133 prior to executing.
