



Explosive Ordnance Disposal Technicians (EOD). EOD Technicians perform operations which include: location, identification, render safe and disposal of foreign and domestic ordnance including conventional, chemical, biological, nuclear, underwater, and improvised explosive devices enabling access during operations in support of Carrier and Expeditionary Strike Groups, Mine Countermeasures, Naval Special Warfare, and Army Special Forces. Perform location and identification of Weapons of Mass Destruction (WMD) and Improvised WMD. Provide training and assistance for military, federal, state, and local civilian law enforcement agencies in ordnance related Anti-Terrorism/Force Protection procedures. Support and conduct ordnance related exploitation, intelligence collection, and counter-terrorism operations. Operate, maintain, and repair specialized EOD and combat equipment. Maintain required forms, records, correspondence, and files. Duties include performing open and closed-circuit SCUBA diving, explosive demolitions, parachuting, tactical delivery, and extraction by unconventional insertion methods and small arms proficiency.

## 1. EOD Navy Enlisted Classifications (NECs):

The EOD rating has three primary Navy Enlisted Classification (NEC) codes (M02A/M03A/M04A) which are required for advancement and signify an increased level of knowledge and responsibility, similar to the Navy's apprentice, journeyman, and master skill designations used to describe other technical rates.

The EOD rating has secondary NECs described in the Navy Enlisted Manpower and Personnel Classifications and Occupational Standards (NEOCS) manual which are not prerequisites for advancement within this career path.

In 2022, EOD established Career Leadership Milestone tracking NECs to denote completion of leadership milestone tours within EOD commands. These NECs are awarded only after the successful completion of the leadership milestone tours listed in Para. 3 and 5. The table below lists the EOD Career Milestone NECs.

NOTE: Minimum time in milestone is not the only determinate of Milestone Completion. The member must be explicitly indicated as "Milestone Complete" by NEC, Performance Evaluation, or MFR.

## 2. CONSIDERATIONS FOR ADVANCEMENT

## FULLY QUALIFIED EOD Technicians:

- SHALL demonstrate sustained superior performance at sea
- SHALL hold NEC M04A for advancement to E7 / E8 / E9





- SHALL hold the appropriate Leadership Milestone NEC at their current paygrade
  - Advancement from E6 to E7: M04L
  - Advancement from E7 to E8: M04P
  - Advancement from E8 to E9: M04C
  - NOTE: A Memorandum for the Record (MFR) on command letterhead, signed by the CO to the service member, validates NEC or LPO/LCPO milestone completion during a time frame that is not annotated in a regular report ONLY and should only be considered if the member otherwise meets ALL minimum requirements for the milestone.
- SHALL have been qualified in all CORE QUALIFICATIONS listed in section 4
- SHALL have completed all prescribed Professional Military Education for their current paygrade
  - o Advancement from E6 to E7: Advanced Leader Development Course
  - o Advancement from E7 to E8: Chief Petty Officer Leader Development Course
  - o Advancement from E8 to E9: Senior Enlisted Academy or Other/Joint Service Equivalent

## **BEST QUALIFIED EOD Technicians:**

- SHOULD have a diverse background between Sea and Shore, geographic locations, various echelon commands, and joint duty. Overseas duty is highly valued.
  - UIC 72301 (EODTACDEVEVALSQDN) is a CNO Priority One Command whose members do not follow a normal Sea/Shore rotation and opportunity for diversity of Command assignments is limited.
    \*This note only applies to EODTACDEVEVALSQN Operators.
- Top enlisted leaders in the EOD rating are recognized with the "Santino Leadership Award" or the "Childre Leadership Award"
- SHOULD have earned ENHANCING QUALIFICATIONS (per section 4) if they have served at a command that offered those qualifications
- SHOULD have earned SPECIALIZED QUALIFICATIONS (per section 4) if they have served in a specific duty capacity to earn those qualifications
- SHOULD impact readiness and culture by leading command collateral duties including, but not limited to:
  - o Command EOD Warfare Specialist (EWS) Coordinator
  - o Command Expeditionary Warfare Specialist (EXW) Coordinator
- SHOULD impact peers by leading within FCPOA / CPO Mess
- SHOULD have contributed to EOD rating development including, but not limited to:
  - Senior Enlisted Selection Boards





- o EOD Advancement Exam Rating Review
- EOD PQS/Warfare Program Working Group
- EOD Enlisted Occupational Standards Review Workshop (NEOCS Review)
- SHOULD have completed 1 OFRP within their current paygrade
