



## MN CAREER PATH (SW)



Minemen (MN). MNs are technicians that are responsible for filling the billets of 5 ratings onboard Mine Warfare Platforms and Operational Ordnance Maintenance and Assembly facilities throughout the world. Minemen serve on MCM class ships, HM squadrons, and LCS MIW mission modules. Minemen fill the billets of BM, GM, MN, OS and STG ratings onboard the MCM platform. The Minemen rating is a sea intensive rate in junior paygrades (E1 – E4) balancing in the mid-pay grades (E6 - E7), this balance in the mid-pay grades is to support leadership needed at operational MOMAU's throughout the world.

1. "A" School is required.
2. NPC tour at BUPERS 3 as an Enlisted Community Manager (ECM) are for high-performing E8s. It is a highly competitive tour requiring a thorough understanding of the rating, manning, and manpower policies. Special consideration should be given if the member is fulfilling and has documented performance in this position.
3. A tour at NPC as the "MN" Rating Detailer is a highly competitive tour requiring a thorough understanding of the rating, manning, and manpower policies. Special consideration should be given if the member is fulfilling and has documented performance in this position.
4. Tours at Littoral Combat Ship (LCS PRECOM) require special screening and have longer-than-normal training pipelines. Due to the unique and very specific billets LCS Sailors fill, they are often limited by billet and unable to earn the same qualifications that their counterparts earn on an MCM. Additionally, due to the delay in the delivery of LCS MCM Mission Package systems, Minemen currently aboard LCS are expected to qualify and perform in non-traditional core crew roles which should be viewed favorably. Furthermore, Sailors assigned to LCS before 2018 had more opportunities to qualify in LCS MCM watch stations. Whereas Sailors

assigned after 2018 have had more opportunities to qualify in more core crew watch stations. **Any qualification aboard LCS should be viewed favorably based on its complexity, while having little to no LCS qualifications should be viewed negatively.**

5. Minemen currently serving at EOD Mobile Units should complete LPO/LCPO milestones. A Memorandum for the Record validates LPO/LCPO milestone completion during a timeframe that is not annotated in a regular report or under billet title. Selection Board eligible members can include a copy of the MFR in the Letter to the Board package.
6. Minemen are expected to be masters in all areas of Mine Warfare first. Specifically, Sailors assigned to Avenger Class ships are expected to qualify in all available MCM watch stations and be experts in both CIC and Deck MCM operations. To be considered best, candidates **should** have documented performance in both Deck and CIC when assigned to MCM-1 Class ships.
7. Minemen are the Navy's experts in mine assembly and maintenance. Best qualified MNC/MNCS candidates should have completed NMC or COMOMAG tours. Favorable consideration shall be given to MNCM candidates who have completed successful tours as a LCPO at a NMC and/or COMOMAG as a Mine Readiness Certification Inspection (MRCI) Inspector.
8. The MN rating comprises a broad spectrum of Mine Warfare commands and equipment, with a majority of them located in C3F, C5F, and C7F AOR's. If a candidate's record contains multiple or consecutive tours in a particular geographic location, it should not be viewed negatively, provided the candidate has progressed in billet complexity, professional development, and leadership responsibility. Likewise, those candidates who have demonstrated the ability to succeed in challenging assignments in diverse geographic locations, particularly overseas, may be viewed positively. Due to limited manning onboard most MCM platforms, any out-of-rate qualifications should also be seen favorably.
9. Overseas assignment eligibility is a rating entry requirement for Minemen and **shall** be maintained throughout their career. Minemen in all paygrades should be ready to serve in Forward Deployed Naval Forces (FDNF) commands in Fifth and Seventh Fleet. These FDNF billets are abundant and are typically hard to fill. Favorable consideration should be given to those who have completed an overseas assignment and remain overseas assignable.
10. Chief and Senior Chief Minemen completing a tour at any EOD Mobile Unit **should** earn NEC 757B (UUV Supervisor) following the completion of a 24 month Optimized Fleet Response Plan cycle.
11. Warfare Specialist qualifications are available throughout the MN Community. Best qualified candidates **should** be warfare qualified at every opportunity.
12. LCAC Navigator and Craftmaster is a special program that requires an arduous and extended training program to qualify, with billets that have increased responsibility. Due to the specialized mission of these programs and based on NEC requirements, Sailors are required to re-tour in these communities in order to obtain certain NECs. Though not a closed-loop community, transferring from sea to shore, or shore to sea inside of these programs, is highly desirable and sometimes required because it recycles experience within the program.
13. MTS is a NETC program. All learning center instructors fall under NETC as TYCOM. Other organizations (ATG/CNSG-C/etc.) although have valid 805A billets, do not fall under NETC as TYCOM and MTS is not a requirement.
14. ATS is an Afloat Training Group Program. All personnel assigned to ATG should qualify ATS if available at current command.

### **Considerations for advancement from E8 to E9**

1. To be considered Fully Qualified, candidates **must** have completed requirements for NEC 8SEA.
2. Due to limited MNMCM billets, candidates must be able to serve overseas. Favorable consideration should be given to those who have completed an overseas tour of at least 18 months in a leadership role (LCPO).
3. MNMCM candidates must have a strong knowledge of mine assembly and maintenance. For that reason, ideal candidates **should** have completed a successful tour as a LCPO at a NMC as a Mine Production Officer (MPO) and/or COMOMAG, as a Mine Readiness Certification Inspection (MRCI) Inspector.
4. LCS and EODMU qualifications are driven by the billet assigned and may not be available due to billeting constraints. MCM class ships and ExMCM companies typically have only two Senior Chiefs stationed onboard. Normally this will be the CMDCS and the MNCS. LCS Class ships normally have three Senior Chief Billets, the CMDCS, MNCS, and Top Snipe. This should be given consideration while comparing candidates. Additional favorable qualifications include:
