1. Curriculum Number: 887/883.
2. Curriculum Length in Months: 10.
3. GRE/GMAT Required: No.
4. Purpose: The officer must understand the fundamental concepts and be familiar with the basic functional areas of National Security Law within the Department of the Navy (DON) and the Department of Defense (DoD). The officer must be able to interpret and apply customary international law, state practice, treaties and international agreements, court decisions and legislation as they impact existing and proposed DON/DoD operations, programs and policies. Specific capabilities and requirements include:
 - a. ESR-1: Public International Law.
 - b. ESR-2: Law of Armed Conflict.
 - c. ESR-3: At least two of the following: (1) International Programs; (2) Law of the Sea; (3) Cyberspace Law; (4) Space Law; (5) Information Operations/Intelligence Law; (6) Admiralty/Maritime Law.
5. Coursework Requirements: Officers selected for this track should take a variety of courses within the 1203 subspecialty, but must demonstrate scholarship in Public International Law, Law of Armed Conflict, and at least two of the following areas:
 - a. International Programs.
 - b. Law of the Sea.
 - c. Cyberspace Law.
 - d. Space Law.
 - e. Information Operations/Intelligence Law.
 - f. Admiralty/Maritime Law.
6. Final Project: A dissertation, thesis paper, major report, or capstone project required by the program must focus in depth on legal issues involved in at least one of the eight study areas within the subspecialty.
