FY 19-21 Core Skills Requirements Public Affairs Subspecialty: 4400 Curriculum: 920

Billet subspecialty coding is to be based on the minimum education/training/experience level required for optimum performance. Public Affairs/4400 subspecialty coding is justified when, in addition to general criteria states in NAVPERS 15839 series (Manual of Navy Officer Manpower and Personnel Classification) Part B., the following specific criteria are satisfied:

1. CSR Competencies:

- a. The listed CSRs are a set of quantifiable skills, traits and experiences that a subspecialist must possess to perform at an acceptable level in a coded billet for the 4400/Public Affairs subspecialty.
- b. Public Affairs Subspecialty 4400 S-coded <u>billets</u> are authorized/justified when the <u>billet</u> requires the PAO to have a combination of intermediate-level professional experience and knowledge of public affairs.
 - i. CSR-1: Conduct basic media relations
 - ii. CSR-2: Articulate and communicate and the commander's vision, mission and objectives
 - iii. CSR 3: Create, review, distribute public affairs content and products
 - iv. CSR-4: Implement PA in an operational or high visibility environment
- c. Public Affairs Subspecialty 4400 R-coded billets are authorized/justified when the billet requires the PAO to have a combination of advanced-level professional experience and knowledge of public affairs.
 - i. CSR-1: Design effective public affairs plans and requirements
 - ii. CSR-2: Demonstrate advanced media relations skills and anticipate reactions
 - iii. CSR-3: Advise the Commander and communicate the Commander's vision
 - iv. CSR-4: Lead junior PAOS, enlisted Sailors, and civilians
 - v. CSR-5: Understand Joint warfighting basics

- d. Public Affairs Subspecialty 4400 P-coded billets are authorized/justified when the billet requires the PAO to have completed an approved master's degree.
- e. Public Affairs Subspecialty 4400 Q-coded billets are authorized/justified when the billet requires the PAO to have a combination of advanced-level professional experience and knowledge of public affairs and have an approved master's degree.
 - i. CSR-1: Advise the Commander and staff as a strategic thinker
 - ii. CSR-2: Synchronize with interagency and foreign militaries
 - iii. CSR-3: Lead, advise, and align enterprise PA programs and personnel
 - iv. CSR-4: Understand intersection of policy and politics on command communications
 - v. CSR-5: Joint planning and implementation knowledge

2. Applicable Officer Designator(s) a. 165%

3. Educational and Significant Experience Criteria.

- a. Coded billets are authorized when the functions of the billet include one or more CSR competencies listed above. For additional clarification regarding definition of suffixes, refer to NAVPERS 158391, Vol 1.
