

New MAP Process available for Operational Units with no NSIPS Web internet connectivity

The new automated Meritorious Advancement Program (MAP) process requires online internet connection to the Navy Standard Integrated Personnel System (NSIPS) at https://nsipsprod-sdni.nmci.navy.mil/nsipsclo/jsp/index.jsp. NOTE: The new automated MAP capability is not currently available on shipboard NSIPS Web Afloat servers. Operational units with no internet connection to NSIPS Web should follow a modified automated MAP process diagramed below.

MAP execution for Operational Units with limited/no NSIPS Web bandwidth



The ISIC/TYCOM performs MAP actions in NSIPS Web on behalf of their subordinate command per requests emailed to them in a certification letter from that subordinate command.

This process is similar to the current manual process with one exception: Instead of submitting MAP nominations to PERS 8, commands without access to NSIPS Web are required to submit their MAP nomination request via email directly to their immediate superior in command (ISIC), type commander (TYCOM) or Budget Submitting Office (BSO)/echelon II command using the Meritorious Certification Letter (MCL). The letter must be signed by the commanding officer and should address any exceptions to policy and/or additional quotas requested.
