Notes:

1. MPM 1160-100 OUTLINES the OBLISERV requirements for STAR program reenlistment.
2. Submarine Sailors must be completed with Enlisted Submarine Warfare Qualification in addition to meeting the OBLISERV requirements of MPM 1160-100 when utilizing any of these courses for the STAR program.
3. Must complete required training pipeline and SAR Model Manager PQS to be awarded NEC L00A.
4. Must have completed screening and been selected for Force Recruiting program prior to STAR approval.
5. Must reenlist for 4, 5, or 6 years IAW source rating requirements per COMNAVCRUITCOMINST 1130.8M. (ex. BM initial enlistment requirement is 5 years, member would have to OBLISERV 5 additional years for STAR approval)
6. Must complete NACCS, A-School, SERE and FRS to be awarded G20A NEC. Aircrew package IAW MILPERSMAN 1220-010 must be sent to Aircrew ECM for screening and approval. Must OBLISERV for 4 years from completion of FRS.
7. Must be assigned to NATTC Pensacola, UIC 63093.
