#### Encl: Graduate Education Constructive Credit Waiver Request Memorandum Template

1. <u>Purpose</u>. This SOP establishes the process for Navy Foreign Area Officers (FAOs) to request graduate education constructive credit.

2. <u>Applicability</u>. This SOP applies to all active component (AC) and reserve component (RC) Navy FAOs, supersedes previous versions, and remains in effect until superseded by update or by incorporation into OPNAVINST 1301.10.

#### 3. Background.

a. Navy FAOs must complete a graduate-level degree program per references (a) - (c). The degree should focus on, but is not limited to the historical, political, military and or security, cultural, sociological, economic, scientific and or technical, and geographic factors of specific foreign countries and regions. FAOs who complete a qualified course of instruction at a foreign war college in their assigned region have successfully completed the Master's degree requirement, even if the program does not grant a Master's degree, per reference (c).

b. FAO Detailers make every effort to detail active component officers requiring graduate education to a qualifying program prior to in-zone consideration for commander. In exceptional circumstances, where there was not opportunity to attend graduate school due to timing or needs of the Navy, that member may request graduate education constructive credit. Officers who possess an equivalent level of regional expertise may apply for a constructive credit. Approval authority is delegated by SECNAV to the FAO Community Leader per reference (b).

c. RC FAO applicants must possess a regionally focused international relations or strategic studies graduate degree upon transfer, per reference (c). In exceptional circumstances, where an officer transfers into the RC FAO community without a qualifying graduate degree, that officer may request a graduate education constructive credit via the procedure in section 4.

d. The NPS Regional Security Studies curricula (681-684) establish the baseline for graduate education regional expertise through defined educational skills requirements (ESRs): https://nps.smartcatalogiq.com/en/Current/Academic-Catalog/Graduate-School-of-International-and-Defense-Studies-IDS/Department-of-National-Security-Affairs-NSA.

### 4. Procedure.

FAOs may request graduate education constructive credit from the Assistant Secretary of the Navy for Manpower and Reserve Affairs using the enclosed template. A single incountry tour, in most cases, is insufficient to qualify for constructive credit.

- i. Required elements of the request include:
  - (1) Region for constructive credit request

(2) Documented experience (FITREPs, awards, etc.) that shows:

(a) 3 or more years (aggregate) in-region experience that results in expertise equivalent to the ESRs, or

(b) 3 or more years (aggregate) working in regionally-focused assignment(s) (CONUS or OCONUS) that leads to regional expertise equivalent to the ESRs, <u>or</u>

(c) Combination of 3 or more years of in-region experience and regionallyfocused assignments that leads to regional expertise equivalent to the ESRs

(3) Completion of joint professional military education level one (JPME I)

- ii. Recommended additional elements include:
  - (1) Graduate degree(s) in other field(s) of study
  - (2) Progress in a graduate degree program (in-progress transcript)
  - (3) Participation in non-degree or certificate academic programs
  - (4) Published or unpublished research or articles that demonstrate regional expertise
  - (5) Documented language proficiency (DLPT or OPI) in a regional language
  - (6) Endorsement by senior officer(s) with direct knowledge of requestor's expertise

b. FAOs must route graduate education constructive credit requests through their Council of Captains Regional Lead for review.

c. Regional Leads will review and forward graduate education constructive credit requests to FAO Policy.

d. FAO Policy will staff graduate education constructive credit requests through the Community Chief of Staff for final adjudication by the Community Leader.

## 5. <u>Responsibilities</u>.

a. <u>Regional Leads (as designated by community sponsor)</u> Regional leads will review graduate education constructive credit requests for accuracy of regional expertise claims prior to submission to FAO Policy.

a. <u>FAO Policy (OPNAV N51)</u> FAO Policy will staff request packages to the Community COS and Community Leader for adjudication.
