Original Confinement Order (DD FORM 2707) Latest Revision 1. Only the current version of the DD 2707 will be accepted. 2. The original confinement order must be **completely** filled out. NO copies accepted. Confining offenses **must** be listed on the confinement order. 3. "Medical Certificate" section (9a-10d) must be signed and stamped by a Medical Officer, Nurse Practitioners (NP), or Physician Assistant (PA), certifying fitness for confinement. Any prisoner under the influence of drugs or alcohol (including withdrawal symptoms) and is NOT certified as fit for confinement will be turned away. 4. Female prisoners are not authorized for confinement at NAVCONBRIG Charleston. Results of Trial (ROT). Required for all confinement as a result of Courts-Martial. **Pre-Trial Agreement (PTA)** – if applicable. Charge Sheet (DD FORM 458) Pre-Trial Agreement (PTA). Signed by the accused, the defense counsel, trial counsel and the convening authority.

Victim/Witness Certification and Election Concerning Inmate Status

(DD FORM 2704) Latest Revision

- 1. Only the current version of the DD 2704 will be accepted.
- 2. A DD 2704 is required for every sentence to confinement as a result of Courts-Martial even if there are no victims or witnesses.
- 3. DD FORM 2704 must be **completely** filled out by the Trial Counsel.
