Subj: ANNUAL REPORT, CALENDAR YEAR 2024; LIMITING THE USE OF
RESTRICTIVE HOUSING WITHIN THE NAVY SHORE CORRECTIONS SYSTEM

1. Purpose. To publish annual aggregate restrictive housing (RH) data per references (a) through (d) occurring within U.S. Navy shore military correctional facilities (MCF).

2. Background

a. National correctional reform led to the publication of reference (a) that established policy recommendations for the Department of Justice (DOJ) federal correctional system, including “guiding principles” for all U.S. correctional agencies. Reference (b) directed full implementation of recommendations contained in reference (a).

b. Reference (a) provides the definition of “restrictive housing” as detention that involves three basic elements:

- (1) Removal from the general prisoner population, whether voluntary or involuntary;
- (2) Placement in a locked room or cell, whether alone or with another prisoner; and
- (3) Inability to leave the room or cell for the vast majority of the day (defined as 22 hours or more per day).

c. Per reference (c), in Navy MCFs, RH status is administered in the Special Quarters (SQ) housing unit. The use of RH status will be administered as the exception. On rare occasion, to safely administer the corrections mission, a prisoner may meet the definitional parameters expressed in paragraph 2b above and be considered on RH status.

d. Navy standard correctional practices result in a very limited percentage of the overall MCF population being housed in the SQ on RH status. Additionally, the SQ plan of the day routinely and by design, unless for cause, allows out of cell time for periods more than 2 hours daily (e.g.,

recreation call, sunshine call, showering, programming, etc.). Since 1 September 2016, the guiding principles of reference (a) have been incorporated into pre-existing Navy corrections SQ administration and operations to meet the intent of references (a) and (b). The implementation includes the collection of RH data elements outlined in reference (a).

e. The RH data for the Calendar Year 2024 (CY-24) Annual Report was gathered from Navy shore MCFs – five located within the U.S. and one overseas. The six MCFs where data was collected from are:

- (1) Naval Consolidated Brig (NAVCONBRIG) Charleston, Charleston, South Carolina;
- (2) NAVCONBRIG Charleston Detachment (DET) Chesapeake, Chesapeake, Virginia;
- (3) NAVCONBRIG Miramar, San Diego, California;
- (4) NAVCONBRIG Miramar (DET) Pearl Harbor, Hawaii;
- (5) Pretrial Confinement Facility (PCF), Naval Air Station Jacksonville, Florida; and
- (6) PCF Yokosuka, Japan.

3. General Information

a. On 31 December 2024, within the six U.S. Navy shore MCFs there were 222 prisoners confined. Of this confined population, 208 prisoners were male and 14 were female.

b. During CY-24, within the U.S. Navy shore corrections system, there was a total of 384 new admissions. Of the newly admitted population, 354 male and 30 female offenders.

4. Aggregate Data (CY-24: 1 January 2024 – 31 December 2024)

a. There were 16 occasions which involved four prisoners being housed in the SQ on RH status: One prisoner was placed on RH status 13 times in two separate MCFs, and the other three prisoners were placed on RH status one time each.

b. RH recidivism rate: 25 percent (1 of 4 prisoners with repetitive RH periods).

c. Average length of stay: Charleston (1 prisoner 12 different time for an average of 9.83 days); Chesapeake (0 prisoners, 0 days); Jacksonville (1 prisoner, 15 days); Miramar (0 prisoner, 0 days); Pearl Harbor (0 prisoners, 0 days); and Yokosuka (3 prisoners, 3.33 days).

d. Race: White (3); Unknown (1).

e. Ethnicity: Non-Hispanic (2) and Hispanic (2).

f. Religion: No Preference (2); Catholic (2).

g. Gender: Male (4) and Female (0).

h. Gender Identity: Male (4) and Female (0).

i. Sexual Orientation: Heterosexual (3) Unknown (1).

j. Disability Status: No (4).

k. Age Groups: 21 – 30 (2); 31 - 40 (1); and 41 – 50 (1).
