Subj: LIMITING THE USE OF RESTRICTIVE HOUSING WITHIN THE NAVY SHORE CORRECTIONS SYSTEM; ANNUAL REPORT, CALENDAR YEAR 2022

- 1. <u>Purpose</u>. To publish annual aggregate restrictive housing (RH) data per references (a) through (d) occurring within the U.S. Navy shore military correctional facilities (MCF).

2. Background

- a. National correctional reform led to the publication of reference (a) that established policy recommendations for the Department of Justice (DOJ) federal correctional system, including "guiding principles" for all U.S. correctional agencies. Reference (b) directed the full implementation of reference (a) recommendations.
- b. Reference (a) provides the definition of "restrictive housing" as detention that involves three core elements:
 - (1) Removal from the general prisoner population, whether voluntary or involuntary;
 - (2) Placement in a locked room or cell, whether alone or with another prisoner; and
- (3) Inability to leave the room or cell for the vast majority of the day (defined as 22 hours or more per day).
- c. Per references (c) and (d), prisoners confined in the Navy shore corrections system are housed within either general population (GP) or special quarters (SQ). SQ encompasses administrative segregation (AS) and disciplinary segregation (DS). The categories of AS include medical (MED), prevention of injury (POI), suicide risk (SR), escape risk (ER), potentially violent and dangerous (PVD), pending investigation (PI), loss of privileges (LOP), awaiting transfer (AT), protective custody (PC), and indoctrination (INDOC).

- d. Navy standard correctional practices result in a very limited percentage of the overall MCF population being housed within SQ. Additionally, the SQ Plan of the Day routinely and by design, unless for cause, allows out of cell time for periods more than 2 hours daily (e.g., recreation, sunshine call, showering, programming, etc.). Since 1 September 2016, the guiding principles of reference (a) have been incorporated into pre-existing Navy corrections SQ administration and operations to meet the intent of references (a) and (b). The implementation included the collection of RH data elements outlined in reference (a).
- e. The RH data for the Calendar Year 2022 (CY-22) Annual Report was gathered from six Navy shore MCFs located within the U.S. and one overseas, to include:
 - (1) Naval Consolidated Brig (NAVCONBRIG) Charleston, Charleston, South Carolina;
 - (2) NAVCONBRIG Charleston Detachment (DET) Chesapeake, Chesapeake, Virginia;
 - (3) NAVCONBRIG Miramar, San Diego, California;
 - (4) NAVCONBRIG Miramar (DET) Pearl Harbor, Hawaii;
 - (5) Pretrial Confinement Facility (PCF), Naval Air Station Jacksonville, Florida; and,
 - (6) PCF Yokosuka, Japan.

3. General Information

- a. On 31 December 2022, 290 prisoners were confined within the five U.S. Navy shore MCFs located in the U.S., and one facility located overseas. Of this population, 282 prisoners were male and 8 were female.
- b. During CY-22, there was a total of 541 new admissions into the U.S. Navy shore corrections system, encompassing 508 male and 33 female offenders.
- 4. Aggregate Data (CY-22: 1 January 2022 31 December 2022)
 - a. There were nine total RH incidents that involved seven prisoners within each type of RH status:
 - (1) AS (one AS prisoner occupied AS status during two separate RH periods): 5
 - (a) MED: 0
 - (b) POI: 0
 - (c) SR: 1
 - (d) ER: 0
 - (e) PVD: 1
 - (f) PI: 3

- (g) LOP: 0
- (h) AT: 0
- (h) PC: 0
- (i) PC: 0
- (j) INDOC: 0
- (2) DS: 2
- b. RH recidivism rate: 28.57 percent (2 of 7 prisoners with repetitive RH periods).
- c. Average length of stay: Charleston (two prisoners, 24.5 days); Chesapeake (2 prisoners, 128.5 days); Jacksonville (0 prisoners, 0 days); Miramar (1 prisoner, 2 days); Pearl Harbor (0 prisoners, 0 days); and Yokosuka (2 prisoners, 21 days, and 4 different incidents of RH).
 - d. Race: White (1); Two or More Races (1); and Black/African American (7).
 - e. Ethnicity: Non-Hispanic (8) and Hispanic (1).
- f. Religion: Christian/Non-Denominational (3); No Preference (1); Baptist (1); Islam (1); Other Religious (1) and Atheist (2).
 - g. Gender: Male (8) and Female (1).
 - h. Gender Identity: Male (8) and Female (1).
 - i. Sexual Orientation: Heterosexual (9).
 - j. Disability Status: No (9).
 - k. Age Groups: <+20 (1) and 21 30 (8).
