RMKS/1. This NAVADMIN revises the Active Duty Obligation (ADO) for Naval Reserve Officers Training Corps (NROTC) Navy Option Scholarship recipients who initially commission as Navy Health Professions Officer (HPO). Initial commission must be 1970 Uniformed Services University medical student, 1975 Health Professions Scholarship Program (HPSP) medical student, 1985 HPSP dental student, 1995 HPSP Medical Service Corps (MSC) student, 2300 MSC, or 2900 Nurse Corps. Effective with the release of this message, the ADO for NROTC who initially commission as HPOs will change from five to four years.

- 2. Previously, reference (a) increased the MSR to five years for all NROTC Navy option scholarship recipients who signed a contract on or after 1 July 2010. Reference (b) authorizes The Secretary of the Navy to determine the period of Active Duty to be served by any person receiving advanced education assistance from the Navy.
- References (b) and (c) state that a member must serve on Active Duty for a prescribed period of time. The Active Duty MSR, as stated in reference (a), remains in effect for all other Navy officer communities.
