RMKS/1. Chaplain Corps Religious Ministry Analytics Tool (RMAT) Standard Report now enables data-informed advisement for Spiritual Readiness. - 2. Pursuant to references (a) through (d), commanding officers are required to maximize the readiness of mind, body and spirit, in every member of the command; chaplains advise commanders on all matters pertaining to the Spiritual Readiness of Service Members and their families; and Religious Program Specialists (RP) support Spiritual Readiness with data collection, research, and analysis.
- Throughout FY25, the Chaplain Corps has created more than 1,700 RMAT accounts enabling Chaplains and RPs to record, aggregate, and track the topical attributes of confidential care sessions without compromising or endangering confidentiality.
- 3. The RMAT Standard Report provides four-month trendlines of the top six Personal and Professional Counseling topics as well as the top six Destructive Behaviors associated with these confidential care sessions. The simplicity of the format allows quick, accessible insights for standard work and consistent reporting across the Sea Services.
- 4. Every chaplain and RP has access to this tool and can prepare the Standard Report in order to provide data-informed advisement to the command on factors relevant to Spiritual Readiness. Every supervisory and senior

supervisory Religious Ministry Team has the ability to prepare the Standard Report in an aggregated capacity.

Every commander now has the ability to receive data-informed Spiritual Readiness advisement.

- 5. The RMAT Standard Report is just the beginning of data-informed advisement relevant to Spiritual Readiness. A suite of tools is under development. Like RMAT and the Standard Report, new tools will also honor the confidential care chaplains afford while providing valuable information to commanders to best support our warfighters and their families.
- 6. Commanders are encouraged to engage with their local Religious Ministry Teams to leverage the value of the RMAT Standard Report and maximize readiness of spirit in every member of the command.
