2. On 8 January 2026, the Secretary of the Navy concurred with CHINFO's recommendation that the 38th Annual SNA Conference qualify as an approved external engagement, consistent with Department of War guidance of 15 September 2025 and Reference E. This approval covers all Department of the Navy SNA attendees, including speakers and panel members.
