

**U.S. Navy Uniform Regulations
Summary of Changes (23 August 2021)**

This Summary of Changes provides a brief description of changes made to Navy Uniform Regulations (NAVPERS 15665I) since the last update of 14 May 2021. The changes identified in this summary reflect corrections of noted policy verbiage discrepancies found within NAVPERS 15665I, policy changes announced via NAVADMIN 183/21, and the reissuance of NAVPERS 15665I to NAVPERS 15665J. For specific details of changes, please refer to the noted chapters, sections and articles below.

Updates to Navy Uniform Regulations contained in this summary of changes include:

- Male Grooming (earrings, beards and hair)
- Female Grooming (hair)
- Male and female head coverings
- Prescription Glasses and Sunglasses Authorized Wear
- Jewelry (Wristwatches, Smartwatches, Fitness Tracker and Bracelets)

- Command-at-Sea and Command Ashore/Project Manager Insignia Occasion for Wear
- Identification Badges Manner and Occasion for Wear
- NWU Shoulder Patches Manner and Occasion for Wear
- Clarification of ribbons/medals manner of wear on uniforms with breast pockets.

UPDATES TO NAVY UNIFORM REGULATIONS

1. Chapter 2, Section 2, Article 2201.6.b.1

Deleted:

b. Earrings

(1) Men. Not authorized while in uniform. Additionally, earrings are not authorized in civilian attire when in a duty status or while in/aboard any ship, craft, aircraft, or in any military vehicle or within any base or other place under military jurisdiction, or while participating in any organized military recreational activities. When considered appropriate by the prescribing authority under article 7201.2, earrings may be prohibited while in foreign countries.

Added:

b. Earrings

(1) Men. Not authorized while in uniform or in civilian attire when in a duty status. Earrings may be worn with civilian clothing while in a leave or liberty status on or off military installation and when travelling in a government vehicle, or while participating in any organized military recreational activities ashore unless otherwise prohibited by prescribing authority. When considered appropriate by the prescribing authority under article 7201.2, earrings may be prohibited while in foreign countries.

2. Chapter 2, Section 2, Article 2201.1

Deleted:

1. HAIR

a. Men. Keep hair neat, clean and well groomed. Hair above the ears and around the neck shall be tapered from the lower natural hairline upwards at least 3/4 inch and outward not greater than 3/4 inch to blend with hairstyle. Hair on the back of the neck must not touch the collar. Hair shall be no longer than four inches and may not touch the ears, collar, extend below eyebrows when headgear is removed, show under front edge of headgear, or interfere with properly wearing military headgear. The bulk of the hair shall not exceed approximately two inches. Bulk is defined as the distance that the mass of hair protrudes from the scalp. Hair coloring must look natural and present a complementary appearance. Multicolored hair styles are not authorized. The unique quality and texture of curled, waved, and straight hair are recognized, and in some cases the 3/4 inch taper at the back of the neck may be difficult to attain. In those cases hair must present a graduated appearance and may combine the taper with a line at the back of the neck. One (cut, clipped or shaved) natural, narrow, fore and aft part is authorized. Varying hairstyles, including afro, are permitted if these styles meet the criteria of maximum length and bulk, tapered neck and sides, and do not interfere with properly wearing military headgear. Plaited or braided hair shall not be worn while in uniform or in a duty status. Keep sideburns neatly trimmed and tailored in the same manner as the haircut. Sideburns shall not extend below a point level with the middle of the ear, shall be of even width (not flared) and shall end with a clean shaven horizontal line. Figure 2-2-1. "Muttonchops", "ship's captain", or similar grooming modes are not authorized.

b. Women. This policy applies to female Sailors while wearing the Navy uniform and when wearing civilian clothes in the performance of duty.

(1) Acceptable Hairstyle Criteria. Hairstyles and haircuts shall present a professional and balanced appearance. Appropriateness of a hairstyle shall be evaluated by its appearance when headgear is worn. All headgear shall fit snugly and comfortably around the largest part of the head without distortion or excessive gaps. Hairstyles will not interfere with the proper wearing of headgear, protective masks or equipment. When headgear is worn, hair shall not show from under the front of the headgear. Hair is not to protrude from the opening in the back of the ball cap, except when wearing a bun or ponytail hairstyle. All buns and ponytails shall be positioned on the back of the head to ensure the proper wearing of all headgear.

Lopsided and extremely asymmetrical hairstyles are not authorized. Angled hairstyles will have no more than a 1-1/2 inch difference between the front and the back length of hair. Layered hairstyles are authorized provided layers present a smooth and graduated appearance.

Hair length, when in uniform, may touch, but not fall below a horizontal line level with the lower edge of the back of the collar. With jumper uniforms, hair may extend a maximum of 1-1/2 inches below the top of the jumper collar. Long hair, including braids, shall be neatly fastened, pinned, or secured to the head. When bangs are worn, they shall not extend below the eyebrows. Hair length shall be sufficient to prevent the scalp from being readily visible (with the exception of documented medical conditions).

Hair bulk (minus the bun) as measured from the scalp will not exceed 2 inches. Figure 2-2-2. The bulk of the bun shall not exceed 3 inches when measured from the scalp and the diameter of the bun will not exceed or extend beyond the width of the back of the head. Loose ends must be tucked in and secured.

Hair, wigs, or hair extensions/pieces must be of a natural hair color (i.e. blonde, brunette, brown, red, gray, or black). Hair extensions/pieces must match the current color of hair. Wigs, hairpieces and extensions shall be of such quality and fit so as to present a natural appearance and conform to the grooming guidelines listed herein. Tints and highlights shall result in natural hair colors and be similar to the current base color of the hair.

(2) Hairstyles. Hairstyles shall not detract from a professional appearance in uniform. Styles with shaved portions of the scalp (other than the neckline), those with designs cut, braided, or parted into the hair, as well as dyed using unnatural colors are not authorized. The unique quality and texture of curled, waved and straight hair are recognized. All hairstyles must minimize scalp exposure. While this list shall not be considered all inclusive, the following hairstyles are authorized.

Added:

a. Men. Keep hair neat, clean and well groomed (combed or brushed). Hairstyles and haircuts will present a balanced professional military appearance. Hairstyles/haircuts worn while in uniform or in a duty status will meet the criteria outlined in this paragraph. When wearing the uniform or in a duty status, hairstyles/haircuts will have hair off the ears and above the collar. Hair will be no more than 2 inches in bulk, 4 inches in length and not to extend below the eyebrows when headgear is removed or show underneath when headwear is worn. Bulk is defined as the distance that the mass of hair protrudes from the scalp. Hairstyles worn in uniform will not interfere with the wearing of all uniform covers or the proper wearing of safety equipment. Hairstyles with hair above the ears and around the neck will be tapered from the lower natural hairline upwards at least 3/4 inch and outward not greater than 3/4 inch to blend with longer hair. Hair coloring must look natural. Multicolored hair is not authorized. The unique quality and texture of curled, waved, and straight hair are recognized, and in some cases the 3/4 inch taper at the back of the neck may be difficult to attain. In all cases, hair must present a graduated appearance from the hairline upward. Tapers may include a straight, blocked or round edge line at the back of the neck. One cut, clipped, shaved or natural narrow, fore and aft part, no longer than 4 inches in length and no more than 1/8th inch in width is authorized. Varying hairstyles, including flat top, bald/shaved heads, high and tight, hi-top and low-top fades, afros, and other styles are examples of authorized hairstyles. Plaited, braided, locks, twists, faux hawk hairstyles or hairstyles similar in appearance are examples of unauthorized hairstyles in uniform or in a duty status. Sideburns worn will be neatly

trimmed and tailored in the same manner as the haircut. The hair length of the sideburns will not exceed the hair length where it intersects with the haircut. Sideburns will not extend below a point level with the middle of the ear, will be of even width (not flared) and will end with a clean shaven horizontal line. Sideburns are not authorized with bald hairstyles Figure 2-2-1 refers. "Muttonchops", "ship's captain", or similar grooming modes are not authorized.

b. Women. This policy applies to female Sailors while wearing the Navy uniform and when wearing civilian clothes in the performance of duty.

(1) **Acceptable Hairstyle Criteria.** Hairstyles will not detract from a professional military appearance in uniform. Hairstyles and haircuts will present a balanced professional military appearance. Appropriateness of a hairstyle will be evaluated by its appearance when headgear is worn. All headgear will fit snugly and comfortably around the largest part of the head without distortion or excessive gaps. Hairstyles will not interfere with the proper wearing of headgear, protective masks or equipment. When headgear is worn, hair will not show from under the front of the headgear. Hair is not to protrude from the opening in the back of the ball cap, except when wearing a bun or ponytail hairstyle. All buns and ponytails will be positioned on the back of the head to ensure the proper wearing of all headgear.

(2) Lopsided and extremely asymmetrical hairstyles are not authorized. Angled hairstyles will have no more than a 1-1/2 inch difference between the front and the back length of hair. Layered hairstyles are authorized provided layers present a smooth and graduated appearance.

(3) Hair length, when in uniform, may touch, but not fall below a horizontal line level with the lower edge of the back of the collar. With jumper uniforms, hair may extend a maximum of 1-1/2 inches below the top of the jumper collar. Long hair, including braids, will be neatly fastened, pinned, or secured to the head. When bangs are worn, they will not extend below the eyebrows. Hair length will be sufficient to prevent the scalp from being readily visible (with the exception of documented medical conditions).

(4) Hair bulk (minus the bun) as measured from the scalp will not exceed 2 inches. Figure 2-2-2 refers. The bulk of the bun will not exceed 3 inches when measured from the scalp and the diameter of the bun will not exceed or extend beyond the width of the back of the head. Loose ends must be tucked in and secured.

(5) Hair, wigs, or hair extensions/pieces must be of a natural hair color (i.e. blonde, brunette, brown, red, gray, or black). Hair extensions/pieces must match the current color of hair. Wigs, hairpieces and extensions will be of such quality and fit so as to present a natural appearance and conform to the grooming guidelines listed herein. Tints and highlights will result in natural hair colors and be similar to the current base color of the hair.

(6) Very short length hairstyles will not exceed two inches in bulk and four inches in length anywhere on the head. Very short length hairstyles may also include a taper at the back and side of the head and one straight fore and aft hard part. The lower edge of tapers may be rounded, squared or shapeless. Tapers will extend from the lower hairline at the back and side of the head upward to facilitate gradual blending with longer hair lengths. Hard parts are optional and will not exceed four inches in length and one-eighth of an inch in width. One hard part may be edged, shaved or clipped on the left or right side of the head,

positioned above the temple, but no higher than the crown of the head (approximate area where the side and top of the head meet). Bald hairstyles (razor cut or shaved short) remain unauthorized except in the case of medically prescribed treatments and required care. Styles with shaved portions of the scalp (other than the neckline), those with designs cut, braided, or parted into the hair, as well as dyed using unnatural colors are not authorized. The unique quality and texture of curled, waved and straight hair are recognized. While this list will not be considered all inclusive, the following hairstyles are authorized.

3. Chapter 2, Section 2, Article 2201.2

Deleted:

2. SHAVING AND MUSTACHES (Men). The face shall be clean shaven unless a shaving waiver is authorized by the Commanding Officer per BUPERSINST 1000.22 or a religious accommodation has been granted per BUPERSINST 1730.11. Mustaches are authorized but shall be kept neatly and closely trimmed. No portion of the mustache shall extend below the lip line of the upper lip. It shall not go beyond a horizontal line extending across the corners of the mouth and no more than 1/4 inch beyond a vertical line drawn from the corner of the mouth. The length of an individual mustache hair fully extended shall not exceed approximately 1/2 inch. Figure 2-2-1. Handlebar mustaches, goatees, beards or eccentricities are not permitted. If a shaving waiver is authorized per BUPERSINST 1000.22 or BUPERSINST 1730.11, no facial/neck hair shall be shaved, manicured, styled or outlined nor exceed 1/4 inch in length. **Supervisors of individuals with medical shaving waivers shall actively monitor and ensure treatment regimen is followed.** The following personnel are not authorized to wear any facial hair except when medical waivers or religious accommodation have been granted:

- a. Brig prisoners.
- b. Brig awardees.
- c. Personnel in a disciplinary hold status (i.e., who are serving restriction or hard labor without confinement or extra duties as a result of a court-martial or NJP).
- d. Personnel assigned to a transient personnel unit who are awaiting separation:
 - (1) By reason of a court-martial sentence.
 - (2) To benefit the service (MILPERSMAN 1910-164).
 - (3) Pursuant to the recommendation or waiver of an administrative discharge board, for misconduct (MILPERSMAN 1910-140).

Added:

2. Men. SHAVING AND MUSTACHES. The face will be clean shaven unless a shaving waiver is authorized by the Commanding Officer per BUPERSINST 1000.22 or a religious

accommodation has been granted per BUPERSINST 1730.11. Mustaches are authorized but will be kept neatly and closely trimmed. No portion of the mustache will extend below the lip line of the upper lip. It will not go beyond a horizontal line extending across the corners of the mouth and no more than 1/4 inch beyond a vertical line drawn from the corner of the mouth. The length of an individual mustache hair fully extended will not exceed approximately 1/2 inch. (Figure 2-2-1) refers. Handlebar mustaches, goatees, beards, beneath the lower lip or chin hair are not permitted. If a shaving regimen or waiver is authorized per BUPERSINST 1000.22 or BUPERSINST 1730.11, beards will be properly groomed (clean and combed or brushed). The outer edges of the beard on the face or neck area may be optionally outlined/edged. Outlining, edging or shaping the beard is defined as light clipping or trimming of hair at the very outer edges of the beard to give a shaped appearance. If outlining results in skin irritation discontinue edging the beard. Beards will not exceed 1/4 inch in length unless expressly granted per religious accommodation waiver. **Supervisors of individuals with medical shaving waivers will actively monitor and ensure treatment regimen is followed.** The following personnel are not authorized to wear any facial hair except when medical waivers or religious accommodation have been granted:

- a. Brig prisoners.
- b. Brig awardees.
- c. Personnel in a disciplinary hold status (i.e., who are serving restriction or hard labor without confinement or extra duties as a result of a court-martial or NJP).
- d. Personnel assigned to a transient personnel unit who are awaiting separation:
 - (1) By reason of a court-martial sentence.
 - (2) To benefit the service (MILPERSMAN 1910-164).
 - (3) Pursuant to the recommendation or waiver of an administrative discharge board, for misconduct (MILPERSMAN 1910-140).

4. Chapter 2, Section 1, Article 2101.3.d

Deleted:

d. Glasses

(1) Prescription Glasses. While in uniform, prescription glasses worn will not present a uniform distraction. Prescription glasses that distract from a professional military appearance are not permitted. Retainer straps are authorized for FOD prevention and safety only. If retainer straps are required, they shall be plain, black and worn snugly against the back of the head.

(2) Sunglasses. Conservative sunglasses are permitted, except in military formations. Retainer straps are authorized for FOD prevention and safety only. If retainer straps are required, they shall be plain, black and worn snugly against the back of the head.

Added:

d. Glasses

(1) Prescription Glasses. When in uniform, prescription glasses will be conservative and not present a uniform distraction. Authorized frame colors include silver/grey, black, navy blue, brown, gold, clear or translucent. Frame colors may also consist of a combination of two authorized colors to include framing that holds the lens in place. Lens will be clear. Prescription glasses with transitional lenses, except in military formations are authorized. The lenses must be black, brown, dark green or dark grey when transitioned. When medically prescribed by appropriate military physicians, other tints are authorized per written medical documentation and prescription. Retainer straps are authorized for FOD prevention and safety and will be black in color. If retainer straps are required, they will be worn snugly against the back of the head. When not in use, eyeglasses will not be worn on top of the head or hanging around or off the neck.

(2) Sunglasses. When in uniform and outdoors, conservative sunglasses are permitted, except in military formations. Authorized sunglasses will have solid frames that may be silver/gray, black, brown, navy blue, tan, gold, dark green or dark grey in color. Small logos on frames or lenses are authorized. Sunglasses worn in uniform will not present a uniform distraction. Lens will be non-mirrored black, brown, dark green or dark grey. Retainer straps are authorized for FOD prevention and safety, will be black in color and worn snugly against the head. When not in use sunglasses will not be worn on top of the head or hanging around or off the neck.

5. Chapter 2, Section 2, Article 2201.6.e

Deleted:

e. Bracelets. While in uniform, bracelets shall be conservative. Bracelets that distract from the professional military appearance of the individual in uniform are not authorized. Bracelets may consist of natural metals or fabricated materials (i.e., plastic, wood, silicone) and may be gold, silver, copper, grey, tan, brown, black, white, or light pink in color. Only one bracelet may be worn while in uniform. Ankle bracelets in uniform are not authorized. Bracelets shall not present a uniform distraction, safety or FOD hazard.

f. Wristwatch. While in uniform, wristwatches shall be conservative. Wristwatches that distract the professional military appearance of the individual in uniform are not authorized. Only one watch and one bracelet may be worn simultaneously (one on each wrist) while in uniform.

Added:

e. Bracelets. While in uniform, bracelets will be conservative. Bracelets that distract from the professional military appearance of the individual in uniform are not authorized. Bracelets may consist of natural metals or fabricated materials (i.e., plastic, wood, silicone) and may be solid black, brown, dark green, grey, navy blue, tan, white, copper, gold and

silver only. Only one bracelet may be worn while in uniform. When wearing a bracelet, a wristwatch/smartwatch or fitness tracker is not authorized on the same wrist as the bracelet. Ankle bracelets in uniform are not authorized. Bracelets will not present a safety or FOD hazard.

f. Wristwatch/Smartwatch/Fitness Tracker. While in uniform, wristwatches/smartwatches and fitness trackers will be conservative and not present a uniform distraction. Only one wristwatch/smartwatch or fitness tracker and one bracelet may be worn simultaneously (one on each wrist) while in uniform. Smartwatches and fitness trackers are subject to applicable security regulations. Authorized watch and fitness tracker colors when in uniform are solid black, brown, dark green, grey, navy blue, tan, white, copper, gold (metal), silver (metal), gold and silver combination (metal) only.

6. Chapter 3, Section 1, Article 3101.5.b

Deleted:

b. Embroidery. Embroidered letters on Navy coveralls will be approximately 3/4 inch high blocked letters. Nametapes will match the color and fabric of the uniform component being worn. Length of nametapes will be equal to the width of the pocket. Nametapes (refer to article 3501.18) will be embroidered in gold for officers and CPOs and silver for E1-E6 Sailors except for Navy Working Uniforms.

Added:

b. Embroidery. Embroidered letters on Navy coveralls will be approximately 3/4 inch high blocked letters. Nametapes will match the color and fabric of the uniform component being worn. Length of nametapes will be equal to the width of the pocket. Nametapes (refer to article 3501.18) will be embroidered in gold for officers and CPOs and silver for E1-E6 Sailors except for Navy Working Uniforms. The use of name accents is authorized.

7. Chapter 3, Section 5, Article 3501.18

Deleted:

Ownership Markings. On the waistband inside front at the right of center line. Also, owner's last name shall be embroidered on a name tape, centered approximately 1/4 inch above the right front pocket (measured from the bottom of the lettering to the top stitch of the pocket).

Ownership Markings. On the waistband inside front at the right of center line. Also, owner's last name will be embroidered on a name tape, centered approximately 1/4 inch above the right front pocket (measured from the bottom of the lettering to the top stitch of the pocket). The use of name accents is authorized.

8. Chapter 3, Section 6, Article 3603.10.c

Deleted:

c. Ownership Markings. Last name, first initial and middle initial (if applicable), on label provided inside the parka. A nametape shall be worn on the right shoulder pocket flap of the NWU Type III Parka. The wearer's surname will be embroidered in approximately three fourths of an inch block letters (ALL) on a NWU Type III matching pattern fabric strip approximately one and one fourth inch wide. The nametape shall be sewn centered and flush on the sleeve pocket flap, one fourth of an inch above the bottom of the flap.

Added:

c. Ownership Markings. Last name, first initial and middle initial (if applicable), on label provided inside the parka. A nametape will be worn on the right shoulder pocket flap of the NWU Type III Parka. The wearer's surname will be embroidered in approximately three fourths of an inch block letters (ALL) on a NWU Type III matching pattern fabric strip approximately one and one fourth inch wide. The use of name accents is authorized. The nametape will be sewn centered and flush on the sleeve pocket flap, one fourth of an inch above the bottom of the flap.

9. Chapter 3 Section 6 Article 3603.15

Deleted:

Identification markings will be embroidered in approximately 3/4 inch block letters on approximately 1-1/4 inch wide fabric strips. Names exceedingly long can be embroidered in approximately 1/2 inch letters. Markings will be embroidered in black for E1-O10. Proper locations of fabric strips are as follows:

a. NWU shirt:

(1) Wearer's surname will be sewn centered above and flush with the top of the wearer's right shirt pocket.

(2) "U.S. NAVY" will be sewn centered above and flush with the top of the wearer's left shirt pocket.

(3) Rating badges will not be worn or stenciled on the NWU.

(4) Authorized (current assignment) Force or command/unit patch may be worn on the wearer's right breast pocket. The size of the patch shall not exceed 3 to 3-1/2 inches in length/width/diameter. When worn, the patch will be sewn centered on the pocket below the pocket flap to allow for easy removal and minimum expense.

(5) Authorized Navy certified subdued matching NWU Type II/III pattern Don't Tread On Me (DTOM) and Reverse U.S. Flag (Reverse Flag) patches may be worn on the wearer's left and left right upper arm pocket flap respectively. The optional wear of an embroidered command/unit shoulder patch is authorized for daily wear in nontactical environments. The command/unit logo shoulder patch may be worn on the left shoulder pocket flap of the NWU Type II/III in lieu of the Don't Tread On Me (DTOM) shoulder patch. Simultaneous wear of the command/unit logo patch and the right breast command logo patch is not authorized. Simultaneous wear of the DTOM shoulder patch and right breast command/unit logo patch is authorized. The command/unit shoulder patch will be two and one-quarter inches by four inches in dimension with subdued matching NWU color embroidered logo and lettering. Command/unit logo shoulder patches are considered optional personal purchase items and are not mandatory for wear or possession. The design of command/unit logo patches must be approved by the unit Commanding Officer.

(6) Fabric pull on/off rank insignia tabs shall be worn by E4 and above personnel on the parka/shirt chest pull tab as follows:

(i) Officers, with the exception of vice admirals and admirals, will wear a slip-on version of the regular size embroidered grade insignia. When wearing the eagle insignia, eagle faces to the wearer's right. Vice admirals and admirals will wear a slightly smaller size insignia to accommodate the insignia's proper fit on the tab. The stars will be stacked vertically point to center. Per paragraph 3603.12(f), all Chaplains are authorized to wear their Chaplain Corps Staff insignia above their grade.

(ii) Master, Senior, and Chief Petty Officers will wear a slip-on version of the 1-1/4 inch embroidered cap device on the tab.

(iii) First, Second, and Third Class Petty Officers will wear a slip-on version of the appropriate embroidered petty officer cap device on the tab. The eagle faces to the wearer's right.

(iv) Rating specialty insignias and staff corps devices (with the exception of Navy Chaplains Staff Corps insignia) are not authorized to be worn on the NWU Type II/III.

b. NWU Trousers: The wearer's surname will be sewn centered above and flush with the top of the right rear trouser pocket.

c. NWU Parka: Fabric pull on/off rank insignia tabs shall be worn by E4 and above personnel on the parka's chest pull tab as described in 3603.15.a.(6).

Added:

Identification markings will be embroidered in approximately 3/4 inch block letters on approximately 1-1/4 inch wide fabric strips. Names exceedingly long can be embroidered in approximately 1/2 inch letters. Markings will be embroidered in black for E1-O10. Proper locations of fabric strips are as follows:

a. NWU shirt:

(1) Wearer's surname will be sewn centered above and flush with the top of the wearer's right shirt pocket. The use of name accents is authorized.

(2) "U.S. NAVY" will be sewn centered above and flush with the top of the wearer's left shirt pocket.

(3) Rating badges will not be worn or stenciled on the NWU.

(4) Authorized (current assignment) Force or command/unit patch may be worn on the wearer's right breast pocket. The size of the patch will not exceed 3 to 3-1/2 inches in length/width/diameter. When worn, the patch will be sewn centered on the pocket below the pocket flap to allow for easy removal and minimum expense.

(5) Authorized Navy certified subdued matching NWU Type II/III pattern Don't Tread On Me (DTOM) and Reverse U.S. Flag (Reverse Flag) patches may be worn on the wearer's left and left right upper arm pocket flap respectively. The optional wear of an embroidered command/unit shoulder patch is authorized for daily wear in nontactical environments. Simultaneous wear of the command/unit logo patch and the right breast command logo patch is not authorized. Simultaneous wear of the DTOM shoulder patch and right breast command/unit logo patch is authorized. The command/unit shoulder patch will be two and one-quarter inches by four inches in dimension with subdued matching NWU color embroidered logo and lettering. Command/unit logo shoulder patches are considered optional personal purchase items and are not mandatory for wear or possession. The design of command/unit logo patches must be approved by the unit Commanding Officer.

(6) Fabric pull on/off rank insignia tabs will be worn by E4 and above personnel on the parka/shirt chest pull tab as follows:

(i) Officers, with the exception of vice admirals and admirals, will wear a slip-on version of the regular size embroidered grade insignia. When wearing the eagle insignia, eagle faces to the wearer's right. Vice admirals and admirals will wear a slightly smaller size insignia to accommodate the insignia's proper fit on the tab. The stars will be stacked vertically point to center. Per paragraph 3603.12(f), all Chaplains are authorized to wear their Chaplain Corps Staff insignia above their grade.

(ii) Master, Senior, and Chief Petty Officers will wear a slip-on version of the 1-1/4 inch embroidered cap device on the tab.

(iii) First, Second, and Third Class Petty Officers will wear a slip-on version of the appropriate embroidered petty officer cap device on the tab. The eagle faces to the wearer's right.

(iv) Rating specialty insignias and staff corps devices (with the exception of Navy Chaplains Staff Corps insignia) are not authorized to be worn on the NWU Type II/III.




the camo are not authorized for wear. Shoulder patches are of embroidered (figure 3603.4a-1) or laser cut (figure 3603.4a-2) construction. There are two variants of laser cut DTOM and RF shoulder patches: Tactical and non-tactical. Laser-cut tactical and non-tactical DTOM and RF patches are similar in outward appearance, but are distinguishable by the black backing that makes up the stripes, stars, snake, and DON'T TREAD ON ME. Tactical laser cut patches have shiny Infra Red (IR) taped backing while non-tactical laser cut patches have woven nylon backing.

(2) Command/Unit Logo shoulder patches. With Commanding Officer's concurrence, command/unit logo shoulder patches may be optionally worn in lieu of the DTOM shoulder patch. The Command/unit logo patch will be 2-1/8 x 4 inches or 2-1/4 x 4 inches in dimension with subdued matching NWU color logo and lettering (green, olive, tan, and black coloring). Command/unit logo patches will be embroidered only. The design of command/unit logo shoulder patches must be approved by the unit Commanding Officer.

b. Correct Wear. Wear shoulder patches squarely and centered over the Velcro pile located on the left and right shoulder pocket flap. The DTOM and Command Logo shoulder patches are worn on the left shoulder pocket flap of the NWU Type II and III. The RF patch is worn similarly on the right shoulder pocket flap. Only matching construction shoulder patches will be worn (embroidered or laser cut) together. Wearing patches of different construction (mix and match) is unauthorized. Command Logo shoulder patches may only be worn in lieu of the DTOM patch when the command logo chest patch is not worn on the uniform. Wearing two command patches (right breast pocket and shoulder) is unauthorized. Tactical shoulder patches (with shiny/IR tape backing) are provided by the issuing command and worn during tactical training exercises and deployed tactical missions when determined by the unit commander and Task Force Commander.




a. Description. One or two shoulder patches may be optionally worn on the NWU Type II/III. Optionally worn shoulder patches will be purchased at the wearer's personal expense. Command mandated shoulder patches will be procured and issued by the command directing its wear. Authorized shoulder patch designs include Reverse U.S. Flag (RF), Command/Unit Logos and Don't Tread On Me (DTOM). Command/Unit logo shoulder patch designs must be approved by the unit commanding officer.

b. Design Specifications. Shoulder patches authorized for wear on the NWU Type II and III will be rectangular in shape, 2-1/8 x 3-3/4 inches, 2-1/8 x 4 inches or 2 1/4 x 4 inches in dimension. Patches will consist of subdued matching colors and NWU pattern less black pixels of the NWU worn (that is, the Camouflage fabric will only contain green, olive, and tan coloring). Patches with black in the camouflage pattern are not authorized for wear. Shoulder patches are of embroidered (Figure 3603.4a-1) or laser cut (Figure 3603.4a-2) construction.

c. Correct Wear. Wear shoulder patches squarely and centered over the Velcro pile located on the Left and Right shoulder pocket flap. The RF patch is worn on the right shoulder pocket flap. It is the only shoulder patch that can be worn singularly without another patch being worn on the left pocket flap. The Command/Unit logo or the DTOM patch may be worn optionally on the left shoulder pocket flap when the RF patch is worn on the right pocket flap. Only matching construction shoulder patches will be worn (embroidered or laser cut) together. Wearing patches of different construction (mix and match) is unauthorized. Wearing two Command patches (right breast pocket and left shoulder pocket flap) is unauthorized. Tactical shoulder patches provided by the issuing Command and worn during Tactical training exercises and deployed Tactical missions are not authorized for daily routine wear.

2. Women wear the full size badge centered 1/4 inch above the right breast pocket. On uniforms without breast pockets, place the badge in the same relative position as ribbons/medals. When wearing a name tag, center the device 1/4 inch above nametag. As an option, the command senior enlisted leader identification badge may be worn centered on the left breast pocket. On pockets with flaps, center the badge between the lower point of the flap and bottom of the pocket, midway between the sides. On pockets without flaps, center the badge on the pocket. On the full dress uniforms, center the badge on the left pocket 1/4 inch below the lowest row of medals or below the second breast insignia, if authorized. The badge will be worn in such manner to preserve the dignity and appearance of the Navy uniform.

3. Dinner Dress Uniforms. Men and women wear the miniature size badge 1/4 inch below the lowest row of miniature medals or secondary breast insignia.

(d) Post-tour. Command Senior Enlisted Leaders holding a valid 8CMC/8COB/8CSC NEC who are not assigned to an 8CMC/8COB/8CSC billet may wear the miniature command senior enlisted leader identification badge as follows:

1. Men and women wear post tour CSEL badge in the same position as incumbent CSEL badge is worn.

2. When wearing full dress uniforms, men center the badge 1/4 inch below the lower of either the medals or secondary breast insignia. Women, center the badge 1/4 inch above the left pocket, medals or primary breast insignia.

3. Post-tour wear on formal, dinner dress, and working uniforms is not authorized.

(e) When wearing full dress white, the combination of breast insignia, medals, and identification badge will not extend below the lower seam of the pocket for males. For females, they will not extend lower than the second button on the Service Dress White Coat and no lower than the fourth button on the Service Dress White Chokers.

(4) Per OPNAVINST 1306.2H, commands with designated collateral duty command senior enlisted leaders (CSELs) will wear the appropriate Command Master, Senior, or Chief badge while functioning in that capacity only. Post tour wear is not authorized.

e. Navy, Fleet, Force and Command Senior Enlisted Leader (CSEL) Identification Badges

(1) Eligibility. This badge is worn by all military personnel assigned to and performing the duties of Master Chief Petty Officer of the Navy (MCPON), Fleet Master Chief (FLTCM), Force Master Chief (FORCM), Command Master Chief (CMC) (NEC 8CMC), Chief of the Boat (COB) (NEC 8COB), Command Senior Chief (CSC) (NEC 8CSC), and collateral duty Command Master Chief, Command Senior Chief and Command Chief. Per OPNAVINST 1306.2 (series), commands with designated collateral duty Command Senior Enlisted Leaders (CSEs) will wear the appropriate Command Master, Senior, or Chief badge while functioning in that capacity only. Post-tour wear is not authorized for collateral duty CSEs.

(2) Description. Regular size badges are approximately 1-3/4 inches by 1-3/8 inches. Miniature size badges are approximately 3/4 inches by 7/8 inches. Badges are oval and bordered with a gold chain. The appropriate rate device and identifying silver plate, with applicable raised silver lettering ("Navy", "Fleet", "Force", or "Command"), are centered on a brushed gold background (figure 5101.3e-1). Miniature badges are approximately one-half the size of the regular badge (figure 5101.3e-2). NWU Type III embroidered badges are green with black stitching (figure 5101.3e-3).

(3) Correct Wear. Only one Command Senior Enlisted Leader Identification Badge may be worn at any one time. The badge may be worn during and after the period of detail, except for collateral duty CSELs (who may wear the badge only while designated as CSEL). Wear embroidered badges on the Navy Working Uniform and wear metal badges on all other uniforms as authorized.

(a) Incumbents. The regular size Command Senior Enlisted Leader Identification Badge will be worn on all uniforms except the Dinner Dress Uniforms (wear miniature size).

1. Men and women wear post tour CSEL badge in the same position as incumbent CSEL badge is worn.

2. When wearing full dress uniforms, men center the badge 1/4 inch below the lower of either the medals or secondary breast insignia. Women, center the badge 1/4 inch above the left pocket, medals or primary breast insignia.

3. Post-tour wear on dinner dress and working uniforms is not authorized.

(c) When wearing full dress white, the combination of breast insignia, medals, and identification badge will not extend below the lower seam of the pocket for males. For females, they will not extend lower than the fourth button on the Service Dress White Coat.

Subsequent awards are signified by silver stars added to the wreath and a gold star is issued in lieu of three silver stars. Wear the wreath only while assigned to recruiting billets designated by COMNAVCRUITCOM.

(3) Correct Wear. Wear on the left side. The badge may be worn only on uniforms requiring large medals or ribbons. This badge may be worn only during the period of detail.





(a) Navy Security Forces (NSF) badge/patch. All security LDO/CWO (649X/749X) and rated Master-At-Arms will wear the NSF badge/patch for the duration of their duty within the security career path. Personnel who change designators or rating out of the NSF career field will no longer be authorized to wear the NSF badge/patch.

(b) Correction Specialist badge/patch. All personnel assigned NEC 2008, 9575 or 9516 are authorized to wear the Corrections Specialist badge/patch for the duration of their assignment.

(c) Chief Master-At-Arms (CMAA) badge/patch. Personnel assigned Permanent Change of Station (PCS) to CMAA duties will be authorized to wear the CMAA badge/patch for the duration of their assignment.

(3) Manner of wear. Metal badges will be worn on all uniforms except working uniforms, centered one quarter of an inch above the right breast pocket or nametag, as applicable. On uniforms without a right breast pocket, place it in the same relative position as the ribbons/medals. When wearing a nametag, center the badge one quarter of an inch above the nametag. Embroidered patches matching the design of the metal badge will be worn on working uniforms (NWU Types II and III only) centered above and flush with the wearer's nametape.






Figure 5101.3j-3
Placement of Navy Security Force Badges (Uniforms with Pocket Flaps)





Figure 5101.3j-4






Figure 5101.4a-1 Male Uniform with Pocket Flaps Dual ID Badge




Figure 5101.4a-2 Male Full Dress Dual ID Badge




Figure 5101.4a-3 Male Dinner Dress Blue Dual ID Badge




Figure 5101.4a-4 Male Dinner Dress Blue and White Jacket Dual ID Badge

On pockets with flaps, center ID badges horizontally 1/4 inch above the right pocket or 1/4 inch above the name tag or ribbons (for Full Dress). 


Figure 5101.4b-1 Female Uniform with Pocket Flaps Dual ID Badge (Optional wear)




Figure 5101.4b-2 Female Uniform with Pocket Flaps Dual ID Badge (Optional wear)




Figure 5101.4b-3 Female Uniform without Pocket Flaps Dual ID Badge (Optional wear)




Figure 5101.4b-4 Female Uniform without Pocket Flaps Dual ID Badge (Optional wear)




Figure 5101.4b-5 Female Full Dress Dual ID Badge (Optional wear)




Figure 5101.4b-6 Female Full Dress Dual ID Badge (Optional wear)




Figure 5101.4b-8 Female Dinner Dress Blue Dual ID Badge (Optional wear)




Figure 5101.4b-9 Female Dinner Dress Jumper Dual ID Badge (Optional wear)

1. Manner of Wear. Ribbons are worn on the service coat or jumper of Service Dress Blue, Dress White, and on the shirt of Service Khaki, E6 and below Service Uniform. Ribbons are not authorized on formal dress, dinner dress, or working uniforms. Wear up to three ribbons in a single row. When more than three ribbons are authorized, wear them in horizontal rows of three each. If ribbons are not in multiples of three, the top row contains the lesser number, and the center of this row sits over the center of the one below it. Wear ribbons without spaces between ribbons or rows of ribbons. Wear ribbons with the lower edge of the bottom row centered 1/4 inch above the left breast pocket and parallel to the deck. To prevent coat lapels from covering ribbons, ribbons may be aligned so the border to wearer's left is aligned with left side of pocket. Rows of ribbons where more than 50% of the ribbon is covered by the coat lapel may contain two ribbons each and be aligned with left border. On female coats or shirts without pockets, ribbons will be placed on the wearer's left side with the lower row of ribbons placed approximately 6 1/4 inches down as measured from the shoulder seam and centered over the front seam. On Full Dress uniforms, see article 5313.

5312. RIBBONS




Figure 5-3-12 Ribbon Placement (when not in a row of three)




Figure 5-3-13 Ribbon Placement (more than 50% of ribbon covered by lapel)

1. Manner of Wear. Ribbons are worn on the service coat or jumper of Service Dress Blue, Service Dress White, and on the shirts of Service Khaki, Summer White, and the E1-E6 Service Uniform. Ribbons are not authorized on formal dress, dinner dress, or working uniforms. Wear up to three ribbons in a single row. When more than three ribbons are authorized, wear them in horizontal rows of three each. If ribbons are not in multiples of three, the top row contains the lesser number, and the center of this row sits over the center of the one below it (Figure 5-3-12). Wear ribbons without spaces between ribbons or rows of ribbons. Wear ribbons with the lower edge of the bottom row centered 1/4 inch above the left breast pocket and parallel to the deck. To prevent coat lapels from covering ribbons, ribbons may be aligned so the border to wearer's left is aligned with left side of pocket. Rows of ribbons where more than 50% of the ribbon is covered by the coat lapel may contain two ribbons each and be aligned with left border (Figure 5-3-13). On female coats or shirts without pockets, ribbons will be placed centered on the wearer's left side with the bottom of the lowest row of ribbons placed approximately 6 1/4 inches down as measured from the shoulder seam and adjust height placement as necessary to accommodate proper placement. 


Figure 5-3-14 Ribbon Placement (female shirt/coat without pockets)

1. Manner of Wear. Large medals are worn on the wearer's left side of the service coat or jumper of Full Dress Blues and Full Dress White. When wearing more than one medal, suspend them from a holding bar that supports the medals' weight. Place the holding bar of the lowest row of medals centered 1/4 inch above the left breast pocket and parallel to the deck. On female coats without pockets, medals will be placed on the wearer's left side with the lower horizontal holding bar placed approximately 6-1/4 inches down as measured from the shoulder seam and centered over the front seam. The bars measure 4-1/8 inches wide, and each row of medals is 3-1/4 inches long from the top of the suspension ribbons to bottom of medals, so that bottom of medals dress in a horizontal line. Multiple rows of medals should be grouped with the same number of medals in each row, with the lesser number in the top row if necessary. A maximum of three medals may be worn side by side in a single row with no overlap. Arrange four or more medals (maximum of five in a single row) following the layout in Table 5-3-1. Overlapping will be proportional and the inboard medal will show in full. Mount the medals so they cover the suspension ribbons of the medals below.

2. Arrangement. Arrange medals in order of precedence in rows from top down, inboard to outboard, within rows. Service members possessing more than five medals may either wear the five senior medals or all of them.

3. Medal of Honor with Large Medals. When wearing either large or miniature medals, wear the Medal of Honor pendant on a suspension ribbon placed around the neck. When wearing this medal with the male and female service dress white coat, place the ribbon outside the coat collar. Place the ribbon between the shirt and coat collar with all other coats.

4. Polishing Medals. The wear of anodized, plated, or highly polished medals is prohibited except for personnel permanently assigned to the U.S. Navy Ceremonial Guard in Washington, D.C.




Figure 5-3-1 Full Dress Blue Male Officer and CPO

5. Medals with Breast Insignia. When wearing large medals with breast insignia, comply with Section 2 of this Chapter figures 5-3-1, 2, 3 and 4.

1. Manner of Wear. Large medals are worn on the wearer's left side of the service coat and jumper of Full Dress uniforms. When wearing more than one medal, suspend them from a holding bar that supports the medals' weight. Place the holding bar of the lowest row of medals centered 1/4 inch above the left breast pocket and parallel to the deck. On female coats without pockets, medals will be placed on the wearer's left side with the lower horizontal holding bar placed approximately 6-1/4 inches down as measured from the shoulder seam and centered over the front seam. The bars measure 4-1/8 inches wide, and each row of medals is 3-1/4 inches long from the top of the suspension ribbons to bottom of medals, so that bottom of medals dress in a horizontal line. Multiple rows of medals should be grouped with the same number of medals in each row, with the lesser number in the top row if necessary. A maximum of three medals may be worn side by side




Figure 5-3-3-a Full Dress Blue Female Officer and CPO




Figure 5-3-3-b Full Dress White Female Officer and CPO (CPOs wear collar insignia)




Figure 5-3-5 Dinner Dress Jacket (Male)




Figure 5-3-6 Dinner Dress Blue Male Officer and CPO




Figure 5-3-7 Dinner Dress White Male Officer and CPO (CPOs wear collar insignia)




Figure 5-3-8 Dinner Dress White and Blue Jacket (Female)




Figure 5-3-9-a Dinner Dress Blue Female Officer and CPO

a. Males. On formal and dinner dress jackets, place the holding bar of the lowest row of miniature medals 3 inches below the notch, centered on the lapel, parallel to the deck, figure 5-3-5. On blue and white service coats, center the holding bar 1/4 inch above the left breast pocket parallel to the deck, figures 5-3-6 and 5-3-7.

b. Females. On formal dress or dinner dress jackets, place the holding bar in the same relative position as on the men's dinner dress jackets, down 1/3 the distance between the shoulder seam and coat hem, figure 5-3-8. On blue and white coats, center the holding bar 1/4 inch above the left pocket flap parallel to the deck, figure 5-3-9. On the female Service Dress White (Choker) Coat, miniature medals will be placed on the wearer's left side with the holding bar of the lowest row of miniature medals placed approximately 6-1/4 inches down from the bottom intersection of the front seam and shoulder seam and centered over the front seam.

c. E1-E6 Jumper Uniforms. On jumper uniforms, men and women place the holding bar of the lowest row of miniature medals 1/4 inch above the pocket parallel to the deck, figure 5-3-10.

2. Arrangement. Wear up to five miniature medals in a row with no overlap. Arrange six or more miniature medals following the layout in Table 5-3-1. Arrange medals in order of precedence in rows from top down, inboard to outboard, within rows. Service members possessing five or more medals may either wear the five senior medals or all of them. On the dinner dress jacket, center up to three miniature medals on the lapel. Position four or more miniatures starting at the inner edge of the lapel extending beyond the lapel on to the body of the jacket.

3. Medal of Honor with Miniature Medals. When wearing miniature medals, wear the Medal of Honor as described in article 5314.3.

4. Polishing Medals. The wear of anodized, plated, or highly polished medals is prohibited except for personnel permanently assigned to the U.S. Navy Ceremonial Guard in Washington, D.C.

5. Miniature Medals with Breast Insignia. When wearing miniature medals with breast insignia, comply with Chapter 5, Section 2.

5315. MINIATURE MEDALS

1. Manner of Wear. Wear miniature medals with all formal dress uniforms and dinner dress uniforms. Each row of miniatures is 2-1/4 inches long, from top of the suspension ribbons to bottom of medals, so the bottom of medals dress in a horizontal line. Position medals so they cover the suspension ribbons of the medals in the rows below.

a. Males. On formal and dinner dress jackets, place the holding bar of the lowest row of miniature medals 3 inches below the notch, centered on the lapel, parallel to the deck, figure 5-3-5. On blue and white service coats, center the lower horizontal holding bar 1/4 inch above the left breast pocket parallel to the deck, figures 5-3-6 and 5-3-7.

b. Females. On formal dress or dinner dress jackets, place the holding bar of the lowest row of miniature medals in the same relative position as on the men's dinner dress jackets, down $\frac{1}{3}$ the distance between the shoulder seam and coat hem, figure 5-3-8. On the female Service Dress Blue coat, center the holding bar of the lowest row of miniature medals $\frac{1}{4}$ inch above the left pocket flap parallel to the deck, figure 5-3-9-a. On the female Service Dress White (Choker) Coat, miniature medals will be placed on the wearer's left side with the holding bar of the lowest row of miniature medals placed approximately $6\frac{1}{4}$ inches down from the bottom intersection of the front seam and shoulder seam and centered over the front seam, figure 5-3-9-b.




Figure 5-3-9-b Dinner Dress White Female Officer and CPO (CPOs wear collar insignia)




Figure 5-3-10 J Dinner Dress Blue and White (Jumper) (E1-E6)

c. E1-E6 Jumper Uniforms. On jumper uniforms, men and women place the holding bar of the lowest row of miniature medals 1/4 inch above the pocket parallel to the deck, figure 5-3-10.

2. Arrangement. Wear up to five miniature medals in a row with no overlap. Arrange six or more miniature medals following the layout in Table 5-3-1. Arrange medals in order of precedence in rows from top down, inboard to outboard, within rows. Service members possessing five or more medals may either wear the five senior medals or all of them. On the dinner dress jacket, center up to three miniature medals on the lapel. Position four or more miniatures starting at the inner edge of the lapel extending beyond the lapel on to the body of the jacket.

3. Medal of Honor with Miniature Medals. When wearing miniature medals, wear the Medal of Honor as described in article 5314.3.

4. Polishing Medals. The wear of anodized, plated, or highly polished medals is prohibited except for personnel permanently assigned to the U.S. Navy Ceremonial Guard in Washington, D.C.

5. Miniature Medals with Breast Insignia. When wearing miniature medals with breast insignia, comply with Chapter 5, Section 2.
