1. **Program Background.** Naval Network Warfare Command's blue team (NBT) detachments are unique commands that assess and assist in threat-mitigation and inform leadership of cybersecurity challenges for afloat and ashore commands. The Service members assigned to NBTs need a solid understanding of cyber security and network administration to properly perform their duties. Service members assigned to NBTs will be offered advanced training and certification opportunities to enhance their skills and knowledge base. NBTs are in the following locations:

- a. NBT West (San Diego) - unit identification code (UIC): 36042
- b. NBT East (Norfolk) - UIC: 36041

2. **Requirements and Qualifications**

a. Service members must be in pay grades E-5 or above and meet the following criteria:

(1) E-5 and E-6 Service members must have Navy enlisted classification (NEC) code 746A, 742A, H08A, or 741A in inventory and completed at least one tour utilizing the aforementioned NECs.

(2) E-7 and above Service members must have NEC 742A or 741A in inventory and completed at least one tour as a documented information system security officer or information system security manager.

b. Preference for assignment would be for Service members with a previous documented tour at an NBT, Navy red team, or

cyber protection team. Pay grade and NEC substitutions are not authorized, unless approved by the gaining command.

3. Transferring Command Requirements

a. Complete all sections of [NAVPERS 1306/92](#) Special Program Screening.

b. Required obligated service (OBLISERV) for this program is 36 months. OBLISERV must be satisfied by reenlistment or extension. **NAVPERS 1070/613 Administrative Remarks is not authorized in lieu of hard OBLISERV.**

c. If the Service member is found suitable, commands must report the following information to the receiving command via message:

(1) Any derogatory entries in section A of [NAVPERS 1306/92](#); and

(2) Whether the Service member's record contains any of the following in the past 36-month period:

(a) One or more physical fitness assessment failures, or

(b) Failure to maintain security clearance.

d. Report suitability and or unsuitability determinations to Navy Personnel Command Enlisted Distribution Division (PERS-40), rating detailer, and gaining command utilizing exhibit 1 of [MILPERSMAN 1306-900](#) within 30 days of receipt of Bureau of Naval Personnel orders. If warranted, submit a waiver utilizing exhibit 2 of [MILPERSMAN 1306-900](#).
