

## CHAPTER V

### PLANNING SERIES NEC CODES

Planning NEC codes are approved for planning purposes only. These NEC codes may be used in conjunction with Navy Training Plans, in developing planned training courses, and other applicable long-range projects. Planning NEC codes are established for assignment on manpower authorizations in the Navy Manpower Requirements System (NMRS) to project requirements in Preliminary Ship Manpower Documents (PSMDs) and Preliminary Squadron Manpower Documents (PSQMDs); and other planning purposes. However, they are not assigned to personnel or billets in the Total Force Manpower Management System (TFMMS).
