6. Navy Talent Acquisition Group (NTAG) Portland, NTAG Northern Plains, NTAG Heartland, NTAG Great Lakes, NTAG Ohio River Valley, NTAG Pittsburgh, NTAG Philadelphia, NTAG New England, and NTAG Mid America.

 - a. Only for new Fleet recruiters with NEC 803R requesting orders to Navy Recruiting Command.
 - b. AIP for Career Recruiter Force Sailors is not authorized.
 - c. The recruiter must be filling an 803R NEC billet and AIP must be stopped if the Sailor loses the 803R NEC, is distributed to a billet outside of the 803R NEC, or distributed to an NTAG that is not approved for AIP.
 - d. Sailors that fail to bid for a recruiting assignment in the AIP approved locations and are force distributed by the Navy are authorized to receive half of the approved maximum rate.
 - e. Definite Recall Sailors with NEC 803R assigned to the approved NTAGs are authorized to receive half of the approved maximum rate.
