# Navy Pay and Personnel Support Center (NPPSC)

## OPS Alerts

**Ops Alert 026-25** Commands must follow guidelines outlined in NAVADMIN 226/23 and this Ops Alert to ensure Sailors are counseled and make a MGIB election within specific deadlines to ensure Sailor's election is accurate and prevent erroneous pay deductions.

**Ops Alert 027-25** Ensure command triad, CPPA, and key POC contact information is up to date in the NSIPS Unit Administration module.

**Ops Alert 028-25** CPPAs will familiarize themselves with the Secondary Dependency application process and provide guidance as necessary to Service members requesting this entitlement.

**Ops Alert 29-25** Submit extensions under this Ops Alert to TSC Norfolk.

**Ops Alert 30-25** Notify all Service members of the pending update and deadline. Assist Service members who are submitting updates to their RED/DA. Track pending RED/DA updates for your command. Ensure Service members for any that are not approved prior to the 21 November 2025 deadline resubmit their changes once the application is restored.


**Ops Alert 31-25** Ensure applicable eCRM Problem Codes are utilized to enhance efficiency. Be advised that due to a lapse in appropriation, travel claim processing timeliness will be affected for the foreseeable future.

**Ops Alert 32-25** CPPA and TSC personnel are to verify that requests and supporting Key Supporting Documents (KSDs) include documentation of both the CO's approval and the local installation's endorsement.

**Ops Alert 33-25** verify that every service member and their family have either a Special Issuance Passport (SIP) or a submitted application (DD Form 1056) before government travel to Guam is arranged.

## Pay & Personnel Information Bulletin's

**PPIB 25-19:** The purpose of this message is to announce command procedures for Fiscal

Year 2026 (FY26) Special Leave Accrual (SLA) entitlement.

**PPIB 25-20:** The purpose of this message is to disseminate the FY-2026 lines of accounting (LOAs) classification to be utilized in processing evacuation travel claims for military dependents (MPN and RPN) to evacuate in connection with Tropical Storm Melissa 25 OCT 2025 for the geographic areas of interest (GAOI).

**PPIB 25-21:** On 11/22/25 Navy Standard Integrated Personnel System (NSIPS) will release an update that will change how Record of Emergency Data (RED) and/or Dependency Application (DA) transactions are electronically signed and saved in the NSIPS RED/DA application. This change will require NSIPS to delete all pending transactions that have not been finalized and released to Sailors' service records by 11/21/25. Sailors that have their transaction deleted will have to input their RED/DA edits again as a new transaction when NSIPS RED/DA application comes back online 11/24/25.
