#### Navy Pay and Personnel Support Center (NPPSC) Updates

#### Key OPS Alerts and eCRM Case Routing Guidance

**NPPSC Ops Alert 016-25** announces a streamlined, Quick Start Guide (QSG) & Standard Operating Procedures (SOP) for Transfers. A user friendly QSG/SOP to assist CPPAs and the TSCs to manage transfer cases efficiently.

NPPSC Ops Alert 017-25 updates NPPSC forms – 1300/5, 1300/6, 1420/1, 1420/3.

**NPPSC Ops Alert 018-25** announces the MyPCS Travel Voucher will no longer be used for travel claim submissions. All travel claims must be submitted via eCRM/Salesforce following TPC Case Routing Guidance.

**NPPSC Ops Alert 019-25** states use of the Government Travel Charge Card (GTCC) for executing Permanent Change of Station (PCS) orders is mandatory for all Navy travelers who are eligible for or already possess a GTCC.

**NPPSC Ops Alert 020-25** Updates procedure for Prioritizing Military Excellence and Readiness Separations.


Click on the CPPA Phase II Supervisor Course Registration link in blue and it will take you to a registration form. You will receive an email from N7 to start your registration.

**NP2 is on a strategic pause.** TPC will no longer except travel submission's from NP2. All submission will be submitted via eCRM.
