**UPDATE: PMK-EE EXTENSION FOR EARLY PROMOTE (EP) CANDIDATES FOR EXAM
CYCLES 250 AND 108**

Release Date: 01/15/2021 Effective Date: IMMEDIATELY

BLUF: Due to the change of the 2020 E-6 periodic evaluation completion date to 15 December 2020, OPNAV N132, has authorized the completion date of the E-7 PMK-EE for EP TIR Waiver candidates only to:

- No later than 29 January 2021 for AD/FTS, Cycle 250
- No later than 31 January 2021 for SELRES, Cycle 108

DISCUSSION: NAVADMIN 223/20 announced the due date for the E-6 periodic evaluations was extended to 15 December 2020. In consideration for the late submission, all EP TIR Waiver E-6 Sailors eligible to participate in the Cycle 250 E-7 NWAE are authorized to complete the E-7 PMK-EE no later than 29 January 2021. All EP TIR Waiver E-6 Sailors eligible to participate in the Cycle 108 E-7 NWAE are authorized to complete the E-7 PMK-EE no later than 31 January 2021.

WHAT THIS MEANS TO YOU:

- ✦ Although the original Cycle 250 E-7 NWAE PMK-EE completion deadline was prior to 1 December 2020, the EAW system has not yet been updated and will still recognize all E-7 PMK-EE completed up to 31 December 2020 as eligible; however, only candidates who have completed their E-7 PMK-EE prior to 1 December 2020 will be eligible for advancement.
- ✦ The only exception to this policy is for E-7 candidate who received an EP in their 2020 periodic evaluation and received an EP TIR waiver. The revised waiver deadline for these Cycle 250 AD/FTS candidates is no later than 29 January 2021 and 31 January 2021 for Cycle 108 SELRES candidates.
- ✦ ESOs can manually override an EAW ineligibility if due to non-completion of PMK-EE for Cycle 250 AD/FTS EP TIR Waiver candidates who complete their PMK-EE between 01 and 29 January 2021 and finalize them as eligible. For Cycle 108 SELRES EP TIR Waiver candidates who complete their PMK-EE between 01 and 31 January 2021, the ESO will not need to manually override their ineligibility as the EAW system has not yet been updated and will still recognize all E-7 PMK-EE completed up to 31 January 2021 as eligible.
