#### PROCEDURE UPDATE: AMPLIFYING GUIDANCE FOR HIGH YEAR TENURE (HYT) EXTENSIONS AND REENLISTMENTS FOR FY-22 MASTER CHIEF PETTY OFFICER (MCPO), SENIOR CHIEF PETTY OFFICER (SCPO) AND CHIEF PETTY OFFICER (CPO) CANDIDATES Release Date: 07/29/2021 Effective Date: Immediately

**BLUF:** With the FY-22 Active Duty MCPO and SCPO results being released later than normally scheduled, OPNAV N132 is issuing the following guidance for the execution of extensions and/reenlistments for High Year Tenure (HYT) Sailors on their last "look" and who may be selected for advancement. This information will also apply to the upcoming FY-22 Active Duty Chief Petty Officer (CPO) selection board. The purpose of this OPS Alert is to ensure that every eligible Sailor approaching HYT is not disadvantaged by the scheduling and timing of this year's selection board results.

#### **DISCUSSION:**

MCPO/SCPO: Due to selection board being convened at later than normal (pre-COVID 19) timeframes; we potentially have Sailors on their last "look" with a HYT date of 31 July 2021, and who, if selected, may choose to continue serving our Navy.

CPO: CPO selection board is scheduled for adjournment on 10 September 2021 and it is unlikely that results will be released by the end of September 2021. Therefore, eligible Sailors with an HYT of 30 September 2021, who were eligible for the selection board, may request a 60-day extension pending results release. We highly encourage applicable Sailors to request the extension now. If the eligible candidates choose not to extend the 60-days to await results, they will transfer to the Fleet Reserve on 30 September 2021, with the lengthy Board for Correction of Naval Records (BCNR) as the only available avenue to accept advancement (after-the-fact).

## WHAT THIS MEANS TO YOU:

- The timeframe to execute an extension will be compressed, be prepared to assist in expediting extensions and reenlistments outside of their normal 60-day notification window.
- This only applies to board eligible candidates in accordance with NAVADMIN 013/21 (paragraph 5.c.) and NAVADMIN 050/21 (paragraph 4.c.) and does not in any way change the eligibility lists within the NAVADMINs.
