PROCEDURE UPDATE: **FY-22 CHIEF PETTY OFFICER BOARD ELIGIBILITY NOTICE TO NUCLEAR TRAINED SAILORS**

Release Date: 08/04/2021 Effective Date: Immediately

BLUF: Nuclear-trained Sailors expecting to be evaluated by the fiscal year 2022 Chief Petty Officer Advancement board must verify board eligibility by reviewing their individual profile sheet for advancement. Discrepancies must be communicated to OPNAV N133D at bullnuke@navy.mil and PERS-802 NPC_Enlisted_SELBD_Elig.fct@navy.mil.

DISCUSSION: On 3 Jul 21 OPNAV N1 began to migrate legacy personnel databases, including the Navy Enlisted System (NES), to the Navy Standard Integrated Personnel Systems (NSIPS). Several of the Navy Enlisted Classification (NEC) changes in NES as of 3 July do not reflect in NSIPS. Throughout the migration, the systems have also encountered numerous other information technology (IT) issues which have further complicated the board eligibility review.

WHAT THIS MEANS TO YOU:

- Viewable NSIPS Data is accurate to 3 July 2021. Examples of IT issues include administrative changes to Sailors NEC codes and Enlisted Management Codes (EMC).
 - Changes can affect board eligibility. N133 and PERS 8 are working closely to maintain board eligibility accuracy.
 - Advancement profile sheets are the best way for Sailors to verify selection board eligibility.
 - N133D actively communicates to PERS 802 all NEC changes that affect board eligibility, so PERS 802 can direct Navy Education & Training Professional Development Center (NETPDC) to update the affected Sailor's advancement profile sheet.
 - Last day to verify and make changes for board eligibility is 09 August 2021. Profile sheets will be the only verifiable way for a Sailor to confirm his/her selection board eligibility.
 - Discrepancies must be communicated to OPNAV N133D at bullnuke@navy.mil and PERS-802 NPC_Enlisted_SELBD_Elig.fct@navy.mil.
