## PROCEDURE UPDATE: MANDATORY USE OF MYPCS TRAVEL VOUCHER

Release Date: 1/6/2023 Effective Date: 1/6/2023

<u>BLUF</u>: Travel claims submitted outside MyPCS Travel Voucher (enterprise Customer Relationship Management (eCRM) and Salesforce) that do not meet exemptions per NAVADMIN 129/22 or this Ops Alert will be returned without action.

<u>DISCUSSION</u>: NAVADMIN 129/22 directed mandatory use of MyPCS Travel Voucher for submission of travel vouchers effective 1 July 2022 by all Active Duty and Training and Administration of the Reserve Sailors, with limited exceptions listed in paragraph 10c. NAVADMIN 129/22 also directed Selected Reserve Sailors executing Active Duty for Operational Support (ADOS) and Recall orders to use MyPCS Travel Voucher to submit travel vouchers.

<u>METHODS FOR TRAVEL VOUCHER SUBMISSION</u>: Primary method of submitting travel claims is the <u>MyPCS Travel Voucher Website</u>. Exemptions from MyPCS Travel Voucher use are:

- Personnel attached to CVN, AS, and LCC
- Reserve Sailors requiring partial travel claim liquidation (Extended TEMADD/TDY for Reserve Mobilization/Demobilization Only)
- Evacuation Claims
- Individual Augmentee (IA) claims
- Department of Defense (DoD) Civilian personnel or Contractors
- Final Travel Claim following Discharge, Separation, or Retirement

For exempt submissions, <u>travel claim case routing guidance</u> is available on the <u>MyNavy HR CPPA Resources</u> website.

Effective immediately, travel claims submitted outside MyPCS Travel Voucher not in concurrence with the above requirements will be closed with the following comment:

"Closed with no action. Only the exceptions listed in NAVADMIN 129/22 and OPS Alert 001-23 are authorized to submit via eCRM. Please resubmit using MyPCS Travel Voucher."

## WHAT THIS MEANS TO YOU:

- **CPPAs** Ensure Service Members utilize MyPCS Travel Voucher as the primary method of travel claim submission unless exempted.
