RMKS/1. The purpose of this advisory is to notify that DFAS has successfully completed the Defense Joint Military Pay System Active and Reserve Component (DJMS-AC and DJMS-RC) System Change Requests (SCRs) revising the military pay Mid-Month (MM) transaction cutoff schedule.

2. The current schedule was adjusted to provide an additional 1-3 days to process pay transactions prior to MM cutoff, enhancing timely pay of entitlements to our Warriors through maximization of processing days for personnel and finance offices.

3. By giving personnel offices more time to process entitlements, Warriors will receive their leave and earnings statements, net pay advices, and early deposit notifications closer to the actual pay date which remains unchanged.
